## **FERC Documents**

## **Orders and Opinions**

- Two separately searchable databases link to full text of FER C Orders.
- Current Issuances database includes all FERC Orders and Opinions since 2004. Search by document type, sector, date, FERC docket numbers and keyword.
- Landmark Orders database includes over 70 significant Orders and Opinions from the last 10 years. Search by sector and full text.

## **Sector Documents**

- Database of documents related to sector activities.
  Includes transcripts of technical conferences, staff reports, rulemaking documents and other documents featured on the FERC website.
- Search documents by text, date, docket number, sector, and document type.

## **Administrative Law Proceedings**

- Search FERC issuances related to Administrative Law proceedings.
- Includes documents beginning in 2004.
- Search by keyword, docket, date, sector and document type.

## **Accounting Guidance**

- Contains final rules, FERC releases and FERC FAQ's related to energy accounting issues.
- Search by text, sector, date and FERC docket number.

## **Rules and Compliance**

#### **Federal Regulations**

- Full text search of current regulations with amendment history.
- Generate custom documents of selected sections.

## **Federal Register**

- Proposed and Final Rules and Notices issued by FERC since 2002.
- Search by text, date and subject.
- Links to summary published in Federal Register.

### **Regulatory History**

- Amendment history searchable by CFR section and date.
- Provides Federal Register citation, with electronic links to Federal Register notices beginning in 1998.

## **FERC Regulatory Agenda**

- Searchable semi-annual rulemaking agenda published by FERC.
- Search by CFR section, date and keyword. Database begins in December, 2002.
- Links to related CFRs and FERC rulings.

## **Current U.S. Code**

- Full text search of current code related to energy regulation and compliance.
- Code sections cross referenced to law sections.
- Generate custom documents of selected sections.

#### **Public Laws**

- Full text documents of recent energy laws.
- Identify U.S. Code changes enacted by recent public laws.

#### **Legislative Status**

- Search database of bills filed in current and last Congressional session.
- Links to summary of bill, status of bill, and full text of bill.

#### **Court Cases**

- Search contested FERC rulings by petitioner, court, case number, date, keyword and FERC docket number.
- Pending court cases database shows case status and includes links to contested rulings.
- Decided cases link to full text of decision.

- Library of over 750 law firm memos updated weekly.
- Search by keyword, firm and date.

#### Glossarv

- Single searchable glossary of definitions published in the CFR and by FERC and Dept of Energy.
- Search by word and, for regulatory definitions, by citation.

 Provides quick access to state public utility commission websites.
