

## Case Study: Hilton Head Island, South Carolina



With permission from a major hotel, the 24-year-old Year Round Pool Company of Hilton Head requested a Change Period from DEHC. The Change Order would allow a test on the cloudiest, problem pool on Hilton Head Island. The pool was named the "Ghost Pool" because the pool was never clear. The hotel has 5 pools on their property and pools are checked regularly and daily by trained service personal from Year Round Pool.

Installation of a P-160 by Savastat-USA was on October 28, 2004.

A routine follow-up was conducted on November 4th 2004 of the 30 day experiment.

## FIRST WEEK RESULTS:

After only 3 days: pool was clear for the first time. The grout lines in the tile on the bottom of the pool were even visible.

After 5 days: Auto-chemicals re-adjusted

After 7 days: No sign of back washing necessary. This pool normally required a daily backwash.
