MANAGING THE THERAPEUTIC RELATIONSHIP:

Empathy, Counter Transference, Vicarious Trauma, and Ethics

— **Jon Conte, PhD**

An opportunity for therapists to discuss the mutual relationship between clinical work and their personal life as well as, review key concepts useful in understanding and managing the therapeutic relationship. Material will include a review of current thinking about vicarious trauma, empathetic engagement, counter transference, therapeutic listening and ethical decision-making. It will outline a model for the management of key processes and suggest ways to remain open, refreshed, and vital in the therapeutic relationship. (Workshop includes 4 hours of ethics content.)

ADVANCED TRAINING FOR FORENSIC INTERVIEWERS: Improving Your Knowledge and Skills in the Interview with Males and with Children who have Developmental Disabilities

— **Deborah Davies, Kee MacFarlane, Martin Henry, Katherine Eagleson**

Designed for child abuse interviewers and supervisors who have previously attended an APSAC Forensic Interview Clinic or (comparable 40 hour interview training program). This institute will focus on refining existing knowledge and skills in relation to two challenging populations; boys and children with developmental and/or cognitive disabilities. It will include topics on: obstacles to disclosure specific to males, differences in interviewing young boys and teens, common myths and mistakes in addition to question design, suggestibility, memory and witness capabilities, and other topics associated with these challenging populations.

BASIC TRAINING IN TRAUMA-FOCUSED COGNITIVE BEHAVIORAL THERAPY

— **Anthony Mannarino, PhD & Judith Cohen, MD**

A review of the theoretical rationale for Trauma-Focused Cognitive Behavioral Therapy (TF-CBT) and the basic components of this treatment model. The basic components include psycho education, affective regulation skills, stress management, creating the trauma narrative, cognitive processing and restructuring, safety education and parenting skills. This Institute will incorporate numerous clinical examples and some complete case presentations.

PEDIATRIC SEXUAL ABUSE: Update On Medical Evaluation, 2006

— **Joyce Adams, MD & Lori Frasier, MD**

A review of recent research studies related to the medical evaluation of child sexual abuse, including a discussion of a tool for the interpretation of medical and laboratory findings in children, recommendations on when and how to test for sexually transmitted diseases, and how to assess the likelihood that conditions such as genital herpes or genital warts were transmitted sexually. Cases demonstrating the appearance of acute and healing genital and anal trauma will be presented, along with an update on the evaluation of adolescent victims of sexual assault and how to interpret the presence or absence of injury in these cases. This is not an introductory workshop.

THE ROLE OF ATTACHMENT IN EARLY INTERVENTION AND PREVENTION OF CHILD MALTREATMENT

Purpose: To increase professional skills and knowledge for mental health professionals, child welfare workers, pediatricians and adolescent medicine specialists in current research on attachment, its central importance in normal and abnormal development and applications to treatment and prevention of early maltreatment.

Dr. Main will present an overview of attachment theory, describe her major research findings and discuss recent applications of attachment research to prevention and intervention. Dr. Main is a seminal thinker and a world-renowned researcher on attachment in children and adults. She has been the prime developer of the Adult Attachment Interview, a brilliant research methodology that reliably assesses attachment in adolescents and adults and predicts the child's attachment to the mother.

Dr. Hess has made major contributions to our understanding of, and will describe, disorganized attachment and the role of frightened and frightening parental behaviors in its development. Disorganized attachment occurs in 75% of maltreated children.

— **Ruth Newton, PhD**, Director, Project SAFECHILD; Psychology Supervisor, St. Vincent de Paul Center for the Homeless

For the first time, Dr. Newton will present her research findings from Project SAFECHILD, an early assessment, identification, and intervention program for homeless children ages birth to 5 and their families. Her unique data set includes the impact that attachment, homelessness, and mother's own childhood history have on the child's cognitive, motor, and language development. Dr. Newton will also describe the comprehensive treatment approach she has developed for children who are found to have insecure and disorganized attachment features. Videotapes will be used to illustrate the levels of intervention needed to support the child's development.

FRONTIERS IN TRAUMA TREATMENT

— **Bessel van der Kolk, MD**, Associate Professor, Harvard Medical School, Brookline, MA

In the wake of new insights into the neurobiology of trauma, a range of new approaches to treatment has been developed. Research on the effect of trauma on affect regulation, perception and other brain functions inevitably lead to conclusions regarding treatment that can be considered fundamental shifts from earlier therapeutic paradigms. Preoccupation with the trauma and learned helplessness require a variety of interventions aimed at restoring active mastery and the capacity to attend to current experience.

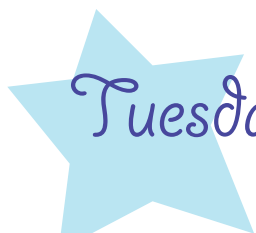

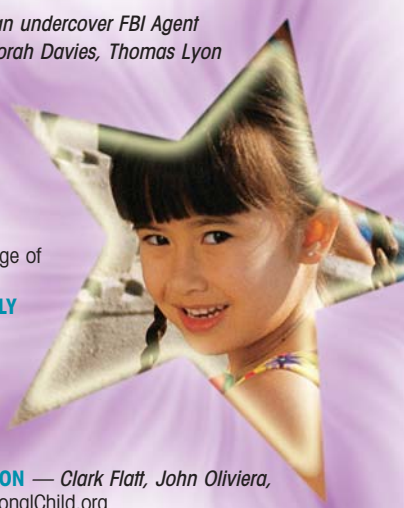
