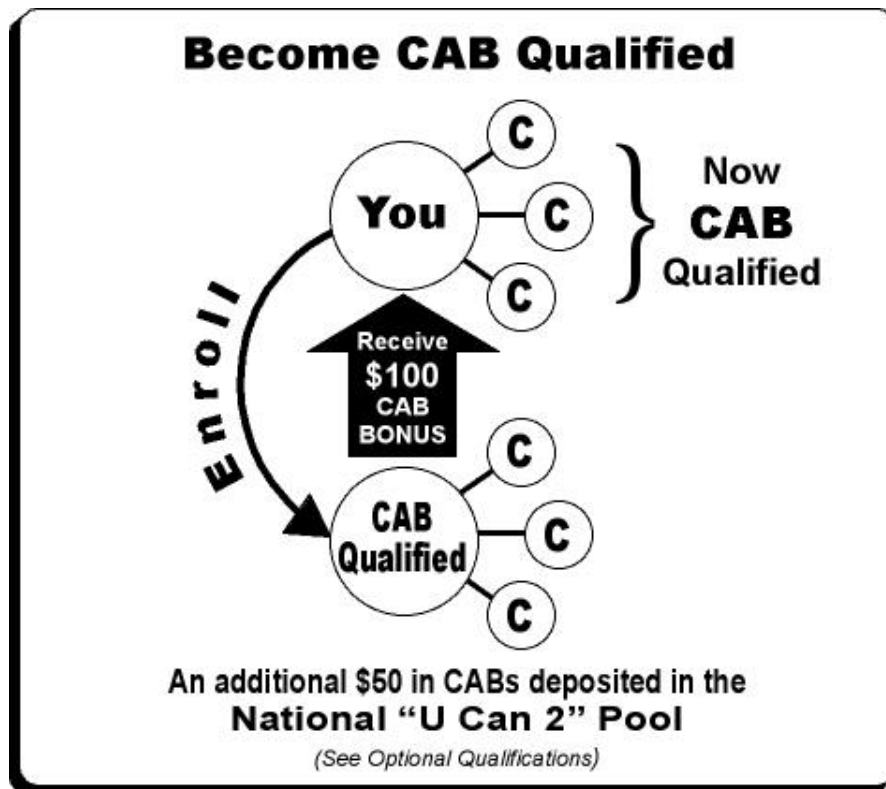
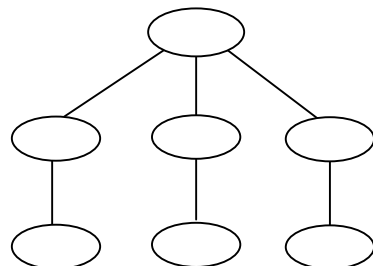


Figure 1. CAB Illustration

The Compensation Plan document explains how to get Customer Acquisition Bonus (CAB) qualified (Figure 1) and how to determine the different pay levels (Figure 2).
