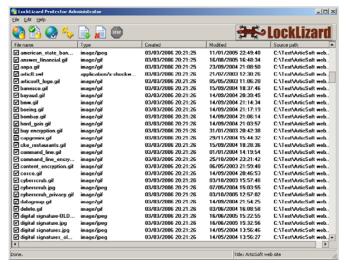
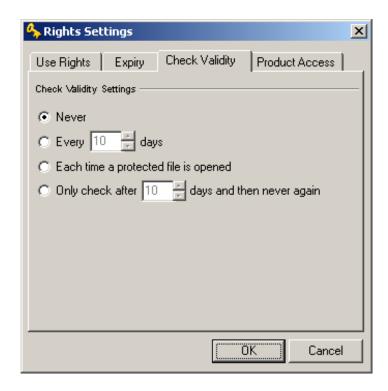


Diagram 1: Document Rights
