Our charges reflect the amount of time and expertise necessary to secure the refund. As this varies from one type of claim to another, so does the fee. You should also be aware that other charges may be due and these are detailed in our terms and conditions below.

Terms & Conditions

The fee is charged at a percentage of the gross refund received and only applied on a no win no fee basis; i.e. no charges are made in the event that no refund is secured. A gross refund is defined as the total of all monies recovered whether those monies are a repayment or to offset outstanding liabilities to HM Revenue & Customs. Any other charges (listed below) will be applied and subtracted from the final refund. A surcharge is applied to refunds under £650 and in the following way: a £20 surcharge for refunds between £401-£650, a £30 surcharge for refunds between £201-£400, a £40 surcharge for refunds up to £200. In the event that a refund is paid by the Revenue in instalments the pricing will apply to the combined total refund not each instalment. Where a customer can not supply all the necessary information or documentation to secure the refund Refunds Direct will secure this in a form that is acceptable to the Revenue and a fee of £15 will be charged for each successful request. If a customer does not have a tax record with the Revenue and a temporary record needs to be set up in order to review the repayment claim and issue a refund a charge of £30 will be applied. Ordinarily refunds will be paid by cheque and posted first class, should customers request a bank transfer to a UK or overseas account a charge of £15 will be applied. Estimates provided to customers are calculated as accurately as possible based on the information available at the time. If further information, supplied by customers, Refunds Direct or HM Revenue & Customs comes to light this may alter the value or validity of a claim.
