A letter or phone call will not protect you. Your written response must be in proper legal form if you want the court to hear your case. There may be a court form that you can use for your response. You can find these court forms and more information at the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), your county law library, or the courthouse nearest you. If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. You can locate these nonprofit groups at the California Legal Services Web site (www.lawhelpcalifornia.org), the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), or by contacting your local court or county bar association.

PARTIES

1. ALL CITIES REALTY, INC. is a corporation organized and existing under the laws of the state of California, and has its principal place of business in Costa Mesa, Orange County, California.

2. ALL CITIES REALTY, INC. is a real estate broker licensed by the State of California.

3. Plaintiff is informed and believes and on that basis alleges that most of the named defendants herein are residents of, and do business in, the County of Los Angeles. Other named defendants are residents of, and do business in the Counties of Ventura, Orange, Riverside, San Bernardino, Santa Barbara, Imperial, and San Diego. All named defendants have or had a business relationship with an entity named CF REAL ESTATE LOANS, INC.

4. CF REAL ESTATE LOANS, INC. is a real estate broker licensed by the State of California, with its principal place of business in Los Angeles County.

5. Plaintiff is unaware of the true names and capacities, whether individual, corporate, associate, or otherwise of defendants Does 1 through 2,000 and therefore sues these defendants by their fictitious names. Plaintiff will seek leave to amend this Complaint when the entities of the Doe defendants are known.

6. Plaintiff is informed and believes and on that basis alleges, that at all relevant times mentioned in this Complaint, defendants, and each of them, were acting in concert and active participation with each other in committing the wrongful acts alleged herein, and were the agents of each other and were acting within the scope and authority of that agency and within the knowledge, consent and approval of one another.

FIRST CAUSE OF ACTION

(For California Common Law Service mark Infringement against all Defendants)

7. Each and every allegation in paragraphs 1 to 6 are incorporated herein by reference.

8. Commencing at least as early as October 29, 1996, and continuously thereafter since until on or about December 14, 1999, Mr. Joseph Miner used the phrase, ALL CITIES REALTY, in the Counties of Los Angeles, Ventura, Orange, Riverside, San Bernardino, Santa Barbara, Imperial, and San Diego, of the State of California as a service mark to identify his brand of services as an agent for individuals and entities in the purchase and sale of real property.

9. On or about October 29, 1996, Joseph Miner filed with the County of

1 Riverside to do business under the fictitious business name ALL CITIES REALTY and
2 was granted a registration. On March 21, 1997, Joseph Miner filed with the County of
3 Orange to do business under the fictitious business name ALL CITIES REALTY and was
4 granted a registration.

5 10. Plaintiff is informed and believes, and on that basis alleges that the phrase
6 ALL CITIES REALTY is inherently distinctive and through advertising and use by Joseph
7 Miner, it has also acquired distinctiveness as being a source identifier for services as a
8 real estate agent and broker coming from Joseph Miner with a significant number of
9 consumers in the in the above named Counties of the State of California.

10 11. On or about December 14, 1999, Mr. Miner transferred and assigned all of
11 his rights, title and interest in the service mark ALL CITIES REALTY, along with the
12 goodwill appurtenant thereto to Plaintiff.

13 12. Commencing on or about December 14, 1999, and continuously thereafter
14 since, Plaintiff has used the phrase ALL CITIES REALTY in the above Counties of the
15 State of California as a service mark to identify its brand of services as an agent for
16 individuals and entities in the purchase and sale of real property.

17 13. Plaintiff is informed and believes, and that basis alleges, that through
18 advertising and use by Plaintiff, the phrase ALL CITIES REALTY has also further
19 acquired distinctiveness as being a source identifier for services as a real estate agent
20 and broker coming from Plaintiff with a significant number of consumers in the above
21 Counties of the State of California.

22 14. Plaintiff is informed and believes, and on that basis alleges, that
23 Defendants, and each of them, are using the service mark ALL CITIES REALTY in
24 connection with their services as real estate agents and brokers in the County of Los
25 Angeles of the State of California and their advertising and reputation extend into the
26 Counties of Ventura, Orange, Riverside, San Bernardino, Santa Barbara, Imperial, and
27 San Diego, of the State of California.

28 15. Plaintiff has not granted any of the Defendants a license or permission to

1 use in any way the service mark ALL CITIES REALTY.

2 16. Plaintiff is informed and believes, and on that basis alleges, that the use by
3 Defendants, and each of them, of the service mark ALL CITIES REALTY is likely to cause
4 confusion, or to cause mistake, or to deceive as to affiliation, connection, or association of
5 Defendants, and each of them, with Plaintiff and/or is likely to cause confusion, or to
6 cause mistake, or to deceive as to origin, sponsorship or approval services by
7 defendants, and each of them, as coming from Plaintiff.

8 17. Plaintiff is informed and believes, and on that basis alleges, that
9 Defendants, and each of them, have plans, designs and intent to continue to use the
10 service mark ALL CITIES REALTY and that Plaintiff has suffered and will continue to
11 suffer irreparable harm by the use by Defendants, and each of them, of the service mark
12 ALL CITIES REALTY, until temporarily and permanently enjoined from using the service
13 mark by this Court.

14 18. Plaintiff is informed and believes, and on that basis alleges, that it has been
15 damaged by the use by Defendants, and each of them, of the service mark ALL CITIES
16 REALTY in an amount according to proof at trial, but no less than \$100,000.00 per
17 defendant.

18 19. Plaintiff is informed and believes, and on that basis alleges, that
19 Defendants, and each of them, have made profits through the use of the service mark
20 ALL CITIES REALTY and under the principles of equity, Defendants, and each of them,
21 ought to be disgorged of this profit in an amount according to proof, but no less than
22 \$250,000.00 per defendant.

23 20. Plaintiff is informed and believes, and on that basis alleges, that
24 Defendants, and each of them, have acted in a base and vile manner by exploiting
25 Plaintiff's reputation and good will in the market place for their own commercial gain and
26 that the acts alleged herein of infringing the service mark were committed willfully,
27 fraudulently and/or with malice in disregard of the rights of Plaintiff such that Defendants,
28 and each of them, ought to pay punitive damages.

1 **SECOND CAUSE OF ACTION**

2 (Statutory Unfair Competition (B & P §17200) Against all Defendants)

3 21. Each and every allegation in paragraphs 1 to 19 are incorporated herein by
4 reference.

5 22. By reason of the foregoing, Defendants, and each of them, have engaged
6 and are in engaging in unlawful, unfair and/or fraudulent business acts, all in violation of
7 California's Unfair Competition Law, Business and Professions Code, Section 17200 et
8 seq.

9 23. Plaintiff is informed and believes, and on that basis alleges, that
10 Defendants, and each of them, have plans, designs and intent to continue to use the
11 service mark ALLCITIES REALTY and that Plaintiff has suffered and will continue to
12 suffer irreparable harm by the use by Defendants, and each of them, of the service mark
13 ALL CITIES REALTY, until temporarily and permanently enjoined from using the service
14 mark by this Court.

15 24. Plaintiff is informed and believes, and on that basis alleges, that
16 Defendants, and each of them, have made profits through the use of the service mark
17 ALL CITIES REALTY that rightfully belonged to Plaintiff and under the principles of equity,
18 Defendants, and each of them, ought to be disgorged of this profit in an amount according
19 to proof, but no less than \$350,000.00 per defendant.

20 **PRAYER FOR RELIEF**

21 Plaintiff, ALL CITIES REALTY, INC., prays for judgment as follows:

22 **On The First Cause of Action**

23 1. Damages in an amount according to proof, but no less than \$350,000.00 per
24 defendant.

25 **On All Causes of Action**

26 2. A permanent injunctions enjoining Defendants, and each of them, and all
27 those acting in concert or participation with Defendants, to refrain from using the service
28 mark ALL CITIES REALTY, or any colorable variation thereof, in connection with services

1 as a real estate agent and other real estate services;

2 3. A disgorgement of profits in an amount according to proof, but no less than
3 \$250,000.00 per defendant.

6 4. Costs of suit herein and

7 5. Such other and further relief as the court deems just in proper.

LOS ANGELES SUPERIOR COURT
CIVIL ALTERNATIVE DISPUTE RESOLUTION (ADR) PROGRAMS
[CRC 201.9(c) Information about Alternative Dispute Resolution]

The plaintiff shall serve a copy of the ADR Information package on each defendant along with the complaint.

ADR PROGRAMS

"Alternative Dispute Resolution (ADR)" is the term used to describe all the other options available for settling a dispute which once had to be settled in court. ADR processes such as arbitration, mediation, early neutral evaluation (ENE), and settlement conferences, are less formal than court and provide opportunities for litigants to reach an agreement using a problem-solving approach rather than the more adversarial approach of litigation.

MEDIATION A neutral third party called a "mediator" helps participants in the dispute create their own resolution. The mediator helps facilitate a discussion in which the parties reach a mutually agreed upon settlement. Therefore, mediation allows for more creative resolutions to disputes than other ADR processes.

The Court Mediation Program is governed by Code of Civil Procedure sections 1775-1775.15, California Rules of Court, Rules 1620-1622 and 1630-1639, Evidence Code sections 1115-1128, and Los Angeles Superior Court Rules, Chapter 12.

ARBITRATION A neutral third party called an "arbitrator" listens to each side in the dispute present its case. The arbitrator, who is an attorney, issues a decision based on the evidence. Although evidence is presented, arbitration is a less formal process than litigation. The decision is non-binding unless the parties agree in writing to binding arbitration.

The Court Arbitration Program is governed by Code of Civil Procedure sections 1141.10-1141.31, California Rules of Court, Rules 1600-1618, and Los Angeles Superior Court Rules, Chapter 12.

ENE A neutral third party called an "evaluator" will provide the parties and their counsel, on a voluntary basis and in a confidential session, the opportunity to make summary presentations of their claims and defenses, including key evidence. After hearing the presentations, the evaluator, who is an experienced lawyer with subject-matter expertise, offers a non-binding evaluation.

The evaluator will also help clarify, narrow or eliminate issues, identify areas of agreement, offer case-planning suggestions, and, if requested by parties, settlement assistance. Although settlement is not the primary goal of ENE, the ENE process can reduce litigation time and costs and promote settlement.

The Court ENE Program is governed by Los Angeles Superior Court Rules, Chapter 12.

SETTLEMENT CONFERENCE A neutral third party called a "settlement officer," who is also a retired judge, assists the parties in negotiating their own settlement and may evaluate the strengths and weaknesses of the case.

JURISDICTIONAL LIMITATIONS

MEDIATION, ARBITRATION & ENE Any case in which the amount in dispute is between \$25,000-\$50,000 per plaintiff, and was not previously referred to the Court ADR Program, can be sent to the Court ADR Program for mediation, arbitration, or ENE by stipulation, election by plaintiff or order of the court.

Parties may *voluntarily* request or initiate a mediation or arbitration proceeding, regardless of the amount in dispute.

SETTLEMENT CONFERENCE Any case, regardless of the amount in dispute, may be ordered to a settlement conference. There is no monetary limit.

REFERRAL INFORMATION

After the Court determines the suitability of a case for ADR, the Court directs the parties to the ADR Department to initiate the ADR process. Once the parties have completed the ADR intake forms, a Neutral may be selected.

NEUTRAL SELECTION

Parties may select a mediator or arbitrator from the Court Party Pay Panel or Pro Bono Panel or may hire someone privately, at their discretion. Parties are assigned to a settlement officer by court staff.

COURT ADR PANELS

PARTY PAY PANEL	The Party Pay Panel consists of mediators and arbitrators who have achieved a specified level of experience in court-connected cases. The parties (collectively) may be charged \$150.00 per hour for the first three hours of hearing time. Thereafter, the parties may be charged for additional hearing time on an hourly basis at rates established by the mediator or arbitrator if the parties consent in writing.
PRO BONO PANEL	The Pro Bono Panel consists of trained mediators and arbitrators who have not yet gained the experience to qualify for the Party Pay Panel and experienced mediators and arbitrators who make themselves available pro bono. Mediators and arbitrators donate their time to the courts as a way of supporting the judicial system. It is the policy of the Court that all pro bono volunteer mediators and arbitrators provide three hours hearing time per case. Thereafter, the parties may be charged for additional hearing time on an hourly basis at rates established by the mediator or arbitrator if the parties consent in writing.
ENE	The Court ENE Panel consists of experienced lawyers who have been trained to serve as neutral evaluators. The evaluators provide preparation time and three hours hearing time per case at no charge. Thereafter, the parties may be charged for additional hearing time on an hourly basis at rates established by the evaluator if the parties consent in writing.
PRIVATE NEUTRAL	The market rate for private neutrals can range from \$200-\$1,000 per hour.

Do I need an attorney for this? While it is recommended to have an attorney and/or receive legal advice before the mediation starts, you are not required to have representation. If you do have an attorney, they may participate in the mediation with you.	
How long does it take? Face-to-face mediations generally last one to three hours. Telephone conciliations, in which the parties do not meet face to face, vary from a few days to several weeks. Much depends on the number of parties involved and the complexities of the issues. When the mediation takes place depends on parties scheduling availability.
