



Since 1990, Dianne has been President of the Regional Planning Partnership, a statewide non-profit advocating a better economy and environment through sound land use planning and regional cooperation. Appointed to statewide agencies by three different Governors, she is a founding officer in two statewide coalitions—the New Jersey Regional Coalition and the Coalition for Affordable Housing and Environment.

### Upendra J. Chivukula, LNJ '98

Assemblyman, NJ General Assembly

A longtime Franklin Township resident and former Mayor, Assemblyman Chivukula is the first Asian Indian American ever elected to the New Jersey State Assembly. Currently serving his second term, the Assemblyman serves as Vice Chair for the Commerce and Economic Development and as a member of the Telecommunications and Utilities, and Transportation Committee.

#### Jun Choi, LNJ '03

Mayor, Township of Edison

Prior to becoming Mayor, Jun worked on education policy as Executive Director of a Student Achievement Task Force at the New Jersey Department of Education. Earning a master's degree from Columbia University, the Mayor has also worked for the US Office of Management and Budget, as well as co-founding a leadership development and education organization.

Professor of Law, Seton Hall School of Law and Chair, NJ State Ethics Commission
Nationally acclaimed for her teaching, Professor Franzese was appointed Chair of the State Ethics Commission by the Governor after serving on his Ethics and Policy Management Task Force.
Paula's casebook, "Property Law and the Public Interest," is recognized as one of the first to expansively explore the public interest dimensions of Property Law.

#### Lee Carlson

Publisher, NJBIZ

D. Lee Carlson has spent more than thirty years in the newspaper business in Northern California, at publications such as the *San Francisco Chronicle* and the *San Jose Mercury News*, before coming to the east coast two years ago. She is the publisher of *NJBIZ*, the only weekly business-to-business publication in New Jersey.

The current Senate President and former Acting Governor of New Jersey, Senator Codey's career in state government has spanned more than three decades. As a Senator, he chaired the Institutions, Health, and Welfare Committee and has earned a reputation for supporting the mentally ill as well as improving healthcare through the New Jersey's Healthcare Reform Act.
