Unlike weak and unmanageable password mechanisms Lizard Safeguard uses public key technology with strong AES 256 bit encryption and a real-time web based licensing system.

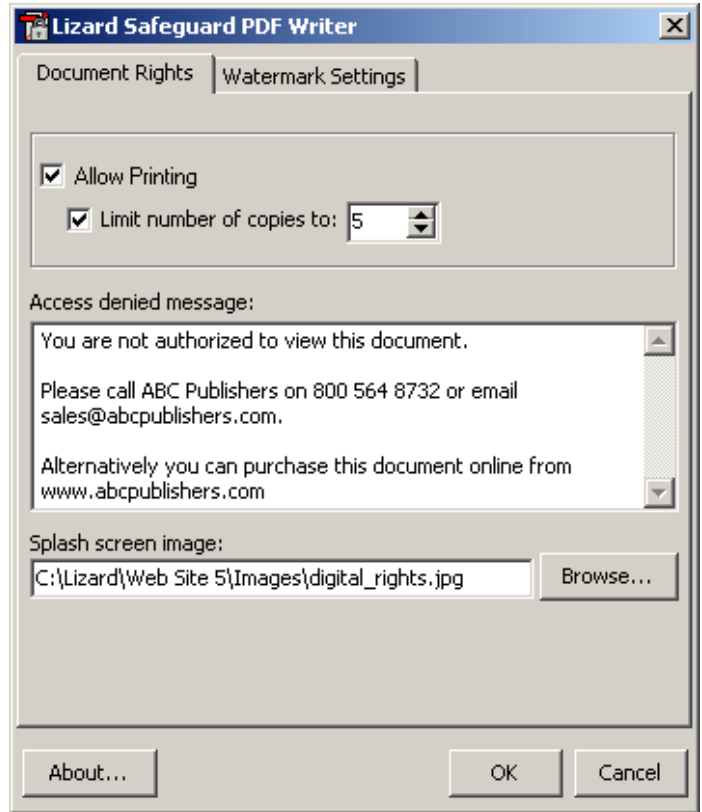


Diagram 1: Document Rights

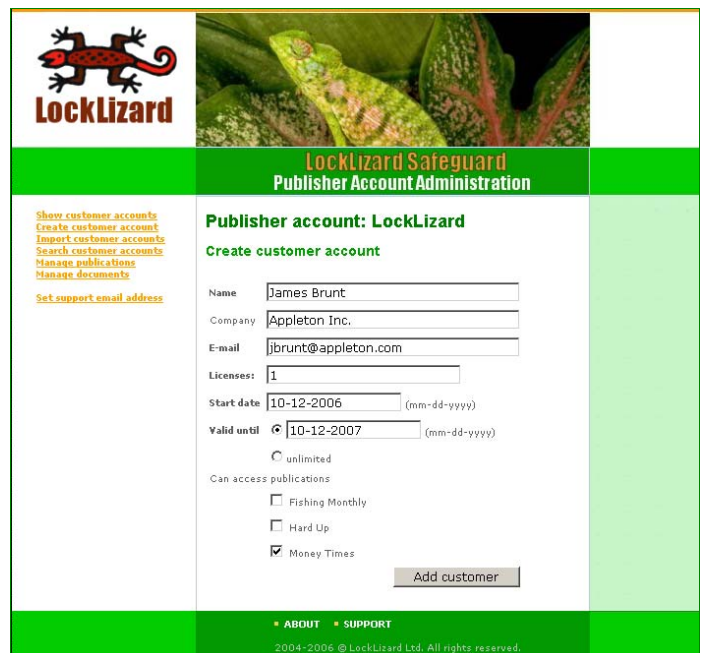


Diagram 2: Web Administration System
