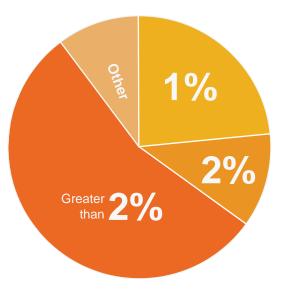

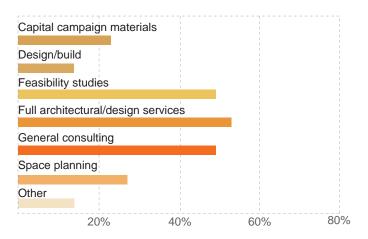

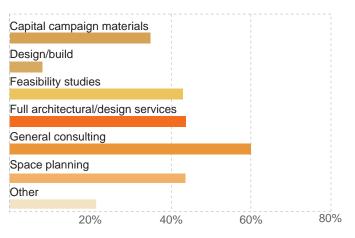

#### Which of the following types of pro bono work has your firm done in the last 12 months?



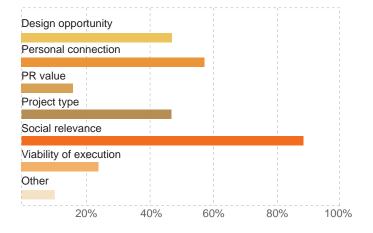
## What types of projects would your firm most like to do more of?



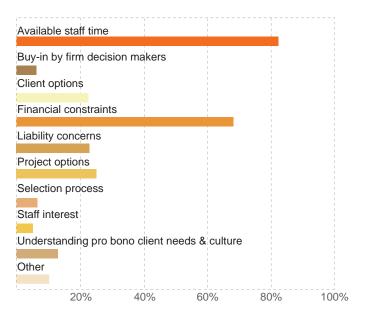
