Mark Bridgers, FMI Management Consultants

He has authored more than 45 publications and reports, and is a three-time winner of national awards for teaching at University of Florida and two-time recipient of the ABC John Trimmer Teaching Excellence Award. He is an inaugural member of the University of Florida's Academy of Distinguished Teaching Scholars. Dr. Cox has been an active member of the Associated Builders and Contractors for more than 20 years and has served on the e-Builder Management Advisory Board since its inception.

He received a B.S. in Architecture degree from the Universidad de los Andes in 1979, a M.S. degree in 1985, and a Ph.D. degree in 1988, from the Construction Engineering and Management Program of the Department of Civil and Environmental Engineering at Stanford University, Stanford, California. He was an Assistant Professor for 5 years in the School of Civil Engineering and the Division of Construction Engineering and Management at Purdue University, West Lafayette, Indiana.
