Next generation emerges in Deloitte Tech' Fast 50

Deloitte today welcomed the next generation of Australia's technology industry's brightest stars to the 2007 Deloitte Technology Fast 50 Awards Ceremony.

Mobile content and applications provider, Mobile Data Group Pty Limited easily rode to the top of the Deloitte Technology Fast 50 league table, with phenomenal revenue growth of 10237%.

The company's performance was only previously surpassed by Bill Express who topped the Asia Pacific Fast 500 in 2004 with 54,000% growth.

Now in its seventh year in Australia, the Deloitte Technology Fast 50 program ranks the 50 fastest growing technology companies, public or private, based on percentage revenue growth over three years (2005–2007).

Deloitte Technology, Media and Telecommunications (TMT) partner, Julia Bickerstaff noted that this year the fastest growing companies in the Deloitte Technology Fast 50 were mobile content and wireless service companies.

"For the third consecutive year internet based companies dominated the field, with 44% of the Fast 50 engaged in internet based businesses. This is a significant jump, up 10% on 2006 results," she said.

According to CEO of Eclipse, Deloitte's online advisory arm, Stuart Johnston, with online increasingly becoming mainstream for business these trends are expected to continue.

"Consumer behaviours have changed dramatically as seen by Web 2.0 trends such as the rise of social networking. When you combine this with the decreased barriers to entry new technologies can provide, we're likely to see the number of online rapid growth success stories continue to increase over time," Mr Johnston said.

"This is particularly the case among smaller businesses that are looking to leverage online technologies and channels to maximise growth and profile. Web 2.0 is a classic example of the huge potential of online, where the marketplace rather than organisations are defining the opportunities and smaller organisations, which are able to adapt quickly are reaping the benefits."

Ms Bickerstaff added that another interesting trend to note is the decline of software companies this year.

"In 2003, 42% of the Fast 50 was software companies, compared to 14% this year," Ms Bickerstaff said.

"Over the same period, companies involved in communications and networking have doubled."

Ms Bickerstaff said this year the average total revenue of Deloitte Technology Fast 50 participants was smaller.

"Total revenue fell to \$903m, less than half the previous year's average total revenues. However, this decline really underlines the changing type of companies in the Fast 50, with this year's table dominated by younger companies in newer industry segments," she said.

The Fast 50 benchmarking survey this year highlighted a dramatic increase in the number of companies seeking business opportunities outside of Australia.

"The United Kingdom, Ireland and Europe combined represent the largest source of potential opportunity for Fast 50 companies, with some 79% of companies see this region as a potential market place, compared to 39% last year," Ms Bickerstaff said.

Keynote speaker at the Deloitte Technology Fast 50 Awards Ceremony was Adrian Giles founder of internet marketing intelligence company, Hitwise.

Hitwise was recognised for its serial success in the Deloitte Fast 50 appearing for five consecutive years (2002-2006) in the league tables. The company was acquired earlier this year by Experian Group Limited for US\$240m.

Rising Star Award

As part of this program, Deloitte also runs the 'Rising Star Award' which focuses on identifying high quality and innovative companies with strong growth potential. These are the businesses that are too small to qualify for the Fast 50 program but are seriously punching above their weight.

The winner of our Rising Star category, Amethon Solutions (Asia Pacific) Pty Limited, is also a player in the mobile space.

Amethon is a mobile analytics solutions company whose products enable mobile operators and content providers to leverage the value of mobile content by managing, monitoring, measuring and monetising mobile content traffic. The company is a global provider of analytical tools and services to mobile telecommunications operators.

2007 Deloitte Fast 50 Fast Facts

Key observations

Our analysis of the Fast 50 shows that:

- more Fast 50 winners call NSW home; this year 46% are based in NSW
- internet based companies dominate the Fast 50, 44% in 2007 compared to 34% in 2006
- mobile content companies have established a strong presence
- there are twice as many privately held companies as publicly listed companies
- half of the Fast 50 were also included in the Fast 50 in previous years
- the companies in this year's Fast 50 are more confident of exploring business opportunities outside of Australia than ever before
- two women CEOs are represented in the Fast 50: Anita Markovic (Adviware Pty Ltd, a previous Fast 50 winner in 2006) and Naomi Simson (Red Balloon Pty Ltd, a previous Fast 50 winner in 2006).

Private companies continue to dominate the Fast 50 in 2007. The tendency in Australia for relatively young companies to list is borne out by 15 companies of the 2007 Fast 50 being listed. This is lower than last year, reflecting the younger profile of companies in the Fast 50 in 2007

Given the fast growth and change in technology, the number of companies which retained their status in the Fast 50 over multiple years is remarkable.

This year 50% of the Fast 50 had been listed in previous years.

In particular we congratulate Seek for appearing in the Fast 50 for the sixth consecutive year and BigAir for appearing in the top 10 for two consecutive years.

Other significant consecutive year winners include; Aconex Pty Ltd (4th consecutive year and in this year's top 10), Destra Corporation Ltd (4th year), carsales.com.au Limited (4th year), Webjet Limited (4th year), Cellestis Limited (3rd year), PIPE Networks Limited (3rd year), Atlassian Software Systems Pty Ltd (3rd year), Customers Limited (3rd year), Real Estate.com.au Limited, message4u Pty Ltd (3rd year) and CogState Limited (3rd year).

Internet based companies dominate the field with 44% of the Fast 50 engaged in businesses based on the internet. This is up 10% on 2006. With increased activity globally in the Web 2.0 space, the rise of

social networks and the presence in Australia of large investors like Google, Microsoft, PBL and News Corp, it would seem that this trend will continue in the Australian context.

It's interesting to note how the dominance of software companies has declined this year. In 2003, 42% of the Fast 50 was software companies, compared to 14% this year. Over the same period, companies involved in communications and networking have doubled.

In keeping with the nature of the complex development cycle for biotech companies, this segment of the Fast 50 has shown little consistent growth to date. From a high of 16% in 2006, this year only 6% of the Fast 50 is biotechnology companies.



Almost half the Fast 50 winners call New South Wales home. The trend for the dominance of New South Wales based companies began in 2005 and shows consistent growth. Victoria maintains second place with 30% of winners' resident there.

Of the top 10 companies five are resident in New South Wales, four in Victoria and one is from South Australia.
