
Note-Link electronically links your handwritten notes directly to the recorded audio and/or video of events captured using FTR Software.

How it works:

1. Record. Note-Link works with ALL FTR recording products.

2. Write. Take notes using the Note-Link digital pen.

3. Dock/Store. Transfer your notes to your computer as a Note-Link PDF file.

4. Search/Find. Retrieve any Note-Link file for review.

5. Click your note. Your handwritten Note-Link retrieves the recording for you.

6. Play. The recording is played at the time you took the note.

5. Click your note



Have you ever looked at your notes and asked "What does that mean?

- Try it now. Seriously. Go find an old notebook and see if you can recall what exactly each note means.
- Note-Link gives you the power to replay that recorded event by simply clicking on your note.

Do you still have paper forms you fill out?

- Note-Link remembers your form AND the information you wrote on the form. Signatures included.
- There's no limit to the number of forms you can have. Note-Link knows which form you're writing on.
- Dock your pen your completed form is saved as a pdf file. No more document scanning.

Are you scanning paper forms in order to get them into your case management, document management or records management system?

- Once you've docked your Note-Link pen your files can be placed in a location for your CMS/RMS to catalog and store for future retrieval.
- Even better your Note-Link forms can replay the recorded event related to that form. Scanned files can't.

Have you ever lost or misplaced your notes?

- Note-Link has redundancy built in. First, you're writing on a piece of paper you can file.
- Second, you have a searchable digital copy.
- Third, you can back it up to another secured location.
