THE IMPACT OF CFATS

The U.S. Department of Homeland Security implementation of comprehensive chemical security regulatory regime under the CFATS Interim Final Rule (6 CFR Part 27) impacts sites containing chemicals at or above the Screening Threshold Quantities (STQs) of Chemicals of Interest (COI) listed in CFATS Appendix A.

High Risk chemical facilities are required to comply with a multi-step, specialized reporting regime known as Chemical Security Assessment Tools (CSATs). Additional requirements include effective application of Risk Based Performance Standards for security in accordance with a specialized Security Vulnerability Assessment (SVA) and with performance metrics delineated in a specialized Site Security Plan (SSP).

CFATS covered sites are subject to detailed inspection and audit regime as well as recurrent reporting requirements.
