WHAT: Sustainable, Repeatable and Reliable Governance and Compliance	The goal of this engagement was to make the company's corporate governance and compliance processes sustainable, repeatable and reliable, while at the same time lowering the TCO (Total Cost of Ownership) of its compliance initiatives worldwide using the right technology and eliminating existing risks hindering current compliance.
WHAT: Streamlining ongoing SOX and other compliance efforts	EnCrisp was engaged to streamline the company's ongoing SOX (Sarbanes-Oxley) and other compliance efforts by enabling a single compliance technology platform. EnCrisp performed SAP GRC Suite (Compliance Calibrator, Access Enforcer, Firefighter and Role Expert) software integration and implementation services along with SOX controls documentation, testing and audit assistance. EnCrisp acted as the client's program manager, business liaison and project manager for SOX control optimization.
WHY: Client Issues	The client had purchased the SAP GRC Suite as one of the SOX documentation automation applications to facilitate data collection and analysis of their compliance-related data. However, the application had not been actively deployed through any formal implementation approach or structured methodology, and so its functionality remained untapped. The company's compliance management group within Finance recognized the need to leverage compliance-related automation frameworks and utilize sustainable approaches in the process to document, test, validate and ascertain the design and operational effectiveness of its internal controls environment.
HOW: Leveraging EnCrisp GRCWeaver content platform for right business rules	Using its proprietary GRCWeaver applications and EnCURE™ Compliance Sustainability Platform, EnCrisp leveraged specific normative models, technical security and SOD rules for developing business compliance and audit scenarios. The compliance queries were deployed in the SAP GRC Suite using (Virsa) Compliance Calibrator and then the right reports were generated to support business and compliance initiatives.
