Pets Letter of Wishes for Joey

Vital Instructions: Pets Letter of Wishes

- 1. Write one Pets Letter of Wishes for each pet.
- 2. If your pet needs care because you're unable to provide a home and proper care, any kind of hitch or delay will be agony for your pet. So, make sure this Letter of Wishes is kept with your other important private documents and keep them all where they will be easily found. Documents of this nature are of no use if they are not found.
- 3. It is important to discuss your wishes with the people you trust to take care of your pet before they may be called upon to do so. Make sure they understand your pet's needs and that they are willing to take care of your pet. It would be disastrous to name someone to care for your pet in your Pets Letter of Wishes only to have that person flatly refuse to do so. You might also discuss whether or not you are leaving a sum of money to help with that care.
- 4. As your Pets Letter of Wishes is not a legally binding document, there is no need in law for it to be witnessed. However, chances that your Executor and the Courts will act on the Letter's expressed intent may increase as you have taken the time and effort to have your signature witnessed.
- 5. Gather together with your two witnesses and explain to them that this document is your Pets Letter of Wishes, designed to protect the future for your pet. Once you have signed the Letter of Wishes, ask them to sign and provide the witness information where shown.
- 6. It's best to choose witnesses who are 18 or over and not named in your Letter of Wishes.
- 7. Make sure you destroy any previous written instructions about your pet's care in any non-legal document, as your new Letter of Wishes should supersede such instructions. If prior instructions were given in a properly signed Last Will & Testament or Living Trust, they appear in documents that have force in law. If you have either of these documents in force, make sure the wishes you express for your pet in your Pets Letter of Wishes are in line with the wishes you express in the Will or Living Trust.
