Construction site theft is a national problem supported by an international black market. Recent and rapid infrastructure growth in India and China has created a thriving market for construction material!

Construction sites are already an inviting target for thieves, with \$1 billion lost annually. The average jobsite will lose \$5000 in tools and materials. With increased demand internationally, construction tools and materials have become a prime target for gangs and organized crime with a high cash return!

April 2008.

A highly organized theft rings specializing in copper theft from houses and warehouses were operating in Minneapolis, Minnesota. These gangs hit several targets per day, yielding more than \$20,000 in profits per month.

Research conducted by the National Association of Home Builders estimates that the cost of a home is inflated approximately \$4000,to compensate for the loss of materials and tools during construction .

Five tornado warning sirens in the Jackson, Mississippi area didn't warn residents of an approaching tornado. Copper thieves had stripped the sirens of copper wiring, rendering them inoperable.

The average contractor will lose \$13,000 a year in tools and materials. The most common targets include, but are not limited too...

> Plumbing supplies and fixtures. Doors and windows Scrap metal Generators Appliances Backhoes Loaders Bobcats Copper Pumps Tools

Tools, equipment and materials that have been installed in the building are often covered by insurance, but are subject to deductibles forcing the contractor to bear the burden of replacement. This doesn't include down time for staff and subs while new tools and materials are purchased.

The Cost of Construction Theft

Construction materials are easy targets and are rarely recovered. The cost of the item is only the hard cost of the loss. When you begin adding in the soft cost, \$1 billion is a fraction of the total.

- Time lost on the job while new materials are acquired or tools are purchased.
 - Increased insurance premiums due to repeated claims.

Reports show that 90% of all equipment thefts occur between the hours of 6pm Friday and 6am Monday. Most construction sites become ghost towns at 4:30 and the lack of security almost invites theft.

Between 2001 and 2008 the price of metal has increased by more than 500 percent!

The FBI and insurance companies recommend the Following preventative measures to reduce the risk of loss.

- l. Secure the site with a chain link fence and post private property signs.
- 2. Install perimeter lighting.
- 3. Install security cameras and post signs that video surveillance is in use.
- 4. Manage access to the site Access Control
- 5. Mark heavy tools and equipment.
- 6. Keep records of serial numbers
- 7. Re-key locks and equipment frequently.
- 8. Install GPS in large equipment and vehicles left on the the site.

While these items are simple in concept, implementation is difficult at best. Until now!
