Importer Security Filing (10+2)

ISF 10+2 Summary

Importer Security Filing, which you probably know as 10+2, is a Customs and Border Protection (CBP) regulation requiring importers and vessel carriers to provide advance data elements to CBP for non-bulk cargo shipments arriving into the United States by vessel. The focus of this initiative is to improve CBP's ability to recognize high-risk shipments in advance to ensure the safety of America's borders.



Data Elements

10+2 Importer Security Filing went into effect on January 26th, 2009. CBP is requiring importers and carriers to transmit these additional data elements 24 hours prior to vessel lading.

- ⦿ Manufacturer Name & Address,
- ⦿ Ship to Name & Address,
- ⦿ Seller Name & Address,
- ⦿ Importer of Record #,
- ⦿ Container Stuffing Location,
- ⦿ Consignee #,
- ⦿ Consolidator Name & Address,
- ⦿ Country of Origin of the Goods,
- ⦿ Buyer Name & Address,
- ⦿ 6 Digit Commodity #.

Carriers (2)

- ⦿ Vessel Stow Plan,
- ⦿ Container Status Message Data.

ISF Mitigation Guidelines

- ◉ We are nearing the 11th hour of ISF. The mitigation guidelines were published in Customs Bulletin & Decisions on July 17th.
- ◉ Four factors may result in liquidated damages. These include; failure to submit, late submission, failure to update or failure to withdraw. Penalties will be assessed as \$5,000 per ISF transmission up to \$10,000,
- ◉ **6 Mitigation Factors:**
 1. Progress of the importer's ISF program,
 2. Percentage of ISFs containing violations,
 3. Tier 2 & 3 C-TPAT members will receive consideration up to 50%,
 4. Action taken by the importer after a violation has occurred,
 5. Circumstances beyond the importer's control,
 6. Inaccurate info received by another party w/i the supply chain.



ISF Report Card

U.S. Customs will be providing ISF report cards to importers who request them. This is to be used as an educational tool for reflection on the ISFs filed by the importer. Since we are still in a non penalty phase ISF filers should be using this report to understand the timeliness and accuracy of their filings.

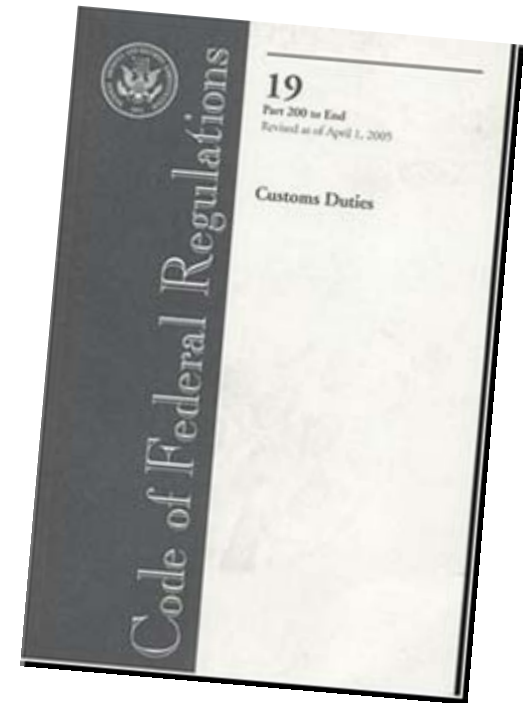

- Publication Date: November 26, 2008
- Effective Date: January 26, 2009
- Compliance Date: January 26, 2010
 - The 12 month period may be extended if circumstances warrant.
 - No liquidated damages assessed for not meeting the new requirements
 - No “do not load” (DNL) holds for compliance issues
- Flexible Enforcement & Structured Review Period
