**Comments:** The agency is unpredictable in that it fails to describe online its citizens' complaint review process, unlike the DOJ's Antitrust Division; In some areas the agency receives "I" for incomplete as it has yet to officially undertake POPULAR's complaint pending before it and numbered 7709; The agency gets an "F" for persistence due to its limited prosecutions of 18 U.S.C. sections 241 and 242 violations; U.S. Attorney General Holder has yet to acknowledge or otherwise respond to the related request of September 22, 2009 that he meet and work with POPULAR's Executive Director, written by Notre Dame President Emeritus and distinguished human rights advocate Reverend Theodore Hesburgh, To learn more, visit:
