## **Preamble**

When, in the course of human events, it becomes clearly apparent that the governments of humanity can no longer withstand human beings' needs to inflict harm upon oneself or others, and then it becomes the duty of the human race to form an alliance with our governments that will prevent the destruction of life. This is an organization of the governments and humanity that is of the people, by the people, for the people that will work with the people to deter and prevent the self-inflicted injuries and the destruction of human life. This organization is called The Human Services Organization.

#### **Mission Statement**

The Human Services Organization does not discriminate against any persons due to race, sex, religion, disability, religious beliefs, sexual orientation, marital status, age, income, criminal history, employment status, educational background, or medical insurance status.

It is the mission of the Human Services Organization to provide universal health care to all citizens of humanity. It is the mission of this organization to provide medical, legal and moral assistance to all citizens of the United States of America when such hardships warrant such assistance in the absence of the funding on the part of the individuals who need this assistance.

It is the mission of this organization to prevent the destruction of oneself and of human life. It is imperative that others who have sought to injure human life be given the assistance and mercy of the Human Services Organization's Board of Judges. It is our mission to modify and correct the medical and psychological circumstances that promote an individual's need to injure him or herself, and to injure others. Rehabilitation services should be provided in all schools, correctional facilities, substance abuse and behavioral rehabilitation centers and in our workplaces throughout the United States of America.

We offer our prayers and sentiments to all persons that are afflicted with hardships that lead to the injury and destruction of life. We hope that God will help us to fulfill the mission of our organization.

## The Adult Services Organization

#### **Mission Statement**

It is the mission of the Adult Services Organization to provide assistance and support to adults that are in crises. This organization should provide funding to adults that would promote the conception and the procurement of human life. This organization should also provide assistance to the ability of adults to raise and educate their children. It must also provide assistance to help adults to understand the dangers and possible consequences of high-risk sexual behaviors and high risk substance abuse behaviors both in parents and in their children.

#### Section 1.1

#### The Family Planning Services Program

This program will assist all couples that seek to conceive children. Children are humanity's greatest investment. Adults that have difficulty in conceiving should get free and low cost fertility services in local Human Services centers. They should also be educated about the physiological mechanisms that govern conception. Free and low-cost prenatal care should be provided to all women regardless of income or HMO status. Childbirth medical services should also be provided in advance through the Human Services Center's network of obstetricians before, during and after childbirth

#### Section 1.2

## The Marital Crisis Counseling Program

The Human Services Organization should provide free counseling services to help to save marriages which involve children. Divorces impair a children's development as a child, adolescent and adult. Divorces also impose an unbearable financial burden on a single mother and her children. Men can be severely injured be the end of a relationship that has produced their children. Separation from childrearing can and should be examined and remedied through the intervention of Marital Crisis Counselors who can diagnose the problems and provide constructive feedback and support to the couple in question. These services should be provided free of charge.

#### Section 1.3

## **Adult Singles Single's Introduction Program**

Adults and adolescents can be involved in fertility crises which involved an inability to conceive in the absence of partner of the opposite sex. Such crises impair the conception of life and disqualify an adult from achieving the procurement of life. The Human Services Organization should provided dating introduction services to adults for a fee that is consistent with an adult's disposable income. College students should receive such services at no cost. Theses services can be available from online interaction and from dating events. Careful criminal background screening and identification verification should only qualify candidates for these services. These services should be made available to adults on college campuses and in Human Services Centers.

#### Section 1.4

#### **Adult Medical Assistance Program**

The Human Services Organization should make it a priority to assure Health Maintenance Organizations and the general population that essential medical services should be affordable to corporations, companies, government employees and uninsured American citizens. The Human Services Organization should provide a fund that Health Maintenance Organizations can utilize for the costs of catastrophic illnesses. Catastrophic illnesses are life-threatening and require intensive medical treatment and rehabilitation services whose costs are well beyond the reach of employers and businesses in the United States. Uninsured Americans should get these services free of charge or at a co-payment which is consistent with those persons' disposable income.

#### Section 1.5

## **Family Crisis Counseling Program**

The Family Crisis Counseling Program is designed to make sure that a family unit does not disintegrate due to an undue hardship that is beyond the parents' control. A group of child and adult psychologists can work together to diagnose the cause and nature of a family crisis. They can remedy the crisis with special financial and educational assistance for the adults and children. Special counseling can help to defuse a conflict that could potentially destroy the family unit.

#### Section 1.6

#### **Substance Abuse and Counseling Program**

Substance abuse is the most serious affliction that affects the nation's adults. This program will involve several measures to help adults to rebuild their lives after a bout with substance abuse.

- 1. Inpatient evaluation in behavioral rehabilitation facility.
- 2. Outpatient housing which is humane and conducive to an effort to build a career
- 3. Vocational training will help the adult to prepare for a life as a taxpayer. A percentage of the adult's salary will come from this program as an incentive for hiring.
- 4. Job placement assistance and workplace monitoring will insure the best possible chance that a relapse will not occur. It also will give the adult a chance to build a new career with a new identity.
- 5. Marital and family counseling will help a spouse and children to cope with the past and progress with the future.

#### Section 1.7

## **Behavioral Rehabilitation Program**

This program will help adults to deal with the traumas and problems that are associated with acute behavioral disorders. This program will strive to treat patents in outpatient facilities so that inpatient care will be less necessary. Vocational training and medication management should be given to individuals who are enrolled in the program free of charge until the psychological and vocational rehabilitation process is complete. The treatment team should include a psychiatrist, psychological counselor and a nurse practitioner. Training in medication management should be given to these patients. Family therapy should also be given to the affected family members.

## The Child and Adolescent Services Organization

#### **Mission Statement**

It is the responsibility of the adult community to insure that our children and adolescents will have the greatest possible chance of emerging from childhood and adolescence as law-abiding tax payers. Our kids are the future of society as a whole. This organization will try to provide the essential services and support to our kids that they will need in order to become a constructive part of society as adults. The government should invest an infinite amount of taxpayers' money in the future of our kids.

#### Section 2.1

## The Universal Day Care Program

Day programs should be available to parents and their kids regardless of income. Working parents have to trust the integrity of the counselors and day care employees that care for their kids in day care centers. This program will guarantee that all parents and working parents will have access to day care services for their kids in every community in United States. They should have these services regardless of their income. Fees for services should be determined by calculating a family's disposable income and financial situations. These centers can provide generalized training for new parents of babies and toddlers. These centers can provide language, exercise and social training and skills to toddlers and infants who come from households with working families. Government subsidized day care programs should be the norm and not he exception.

#### Section 2.2

## **Universal After-School Programs**

It is imperative that children should have constructive things to do between the times that they are released from school to the time their parents have to pick them up from school. Tutoring services can be given to students that have special needs or learning disabilities. Extra credit programs can give computer training and instruction to students that want to exceed their required course objective. Computer based tutoring can be a cost effective way to help students to achieve their teacher's objectives and to go above and beyond the expectations of their parents and schools.

#### Section 2.3

## **Child and Adolescent Crisis Counseling Program**

It is important that our children and adolescents should understand that drinking alcohol, smoking, using street narcotics and using weapons are detrimental to society and to their health. It is very important that kids know the consequences of engaging in violence and high-risk sexual behaviors. This program will educate students to abide by the law. The program will explain the laws that pertain to adults concerning a wide range of issues that our kids will be facing in their immediate future. This program's instructors will allow adolescents to visit prisons, half-way substance abuse centers and psychiatric facilities so that they will see the end result of behaviors that are detrimental to oneself, to others and to society.

#### Section 2.4

## The Religious Perspectives Project

The Constitution of the United States protects our rights to express and explore our religious beliefs freely without fearing retribution from the government and society. The Human Services Organization does not support agnosticism in our public and private schools. All students have the right to pursue a relationship with the one true God. This program will help students to pursue their understanding of God and of their respective religious faiths through voluntary after-school study groups. Agnosticism leads to a detachment from God which is detrimental to society.

#### Section 2.5

## The Human Reproductive Sciences Education Program

It is the right of all adolescents to understand the processes of human reproduction. It is also the responsibility of parents and educators to inform and educate young male and female adolescents about the dangers of engaging in high-risk sexual behaviors. This program will educate teenagers and young adults about the intricacies of the reproductive process from intercourse to childbirth. It is imperative that young teenage girls understand their growing potential to conceive life. It is also important for teenage boys to understand what reproduction is, how it works and how it can result in the conception of life. This program would include in-school training, voluntary video and written training, and individual counseling by family planning counselors. Special help will be available to young adults who wish to conceive for the first time. Fertility training is an important part of making sure that natural selection continues to succeed it conceiving human life.

## **The Educational Services Organization**

#### **Mission Statement**

All American citizens deserve access to a grammar school, high school and college education. They should be eligible for an education regardless of income, race or age. The Educational Services Organization will oversee the ability of all Americans to achieve the American Dream, Life, Liberty and the Pursuit of Happiness. The Educational Services Organization does not refer to children by race. We refer to all of our kids as human beings which are all created equally in the image and likeness of God. All of our kids deserve equal treatment under the law. This organization will require that all schools, both public and private, will be monitored, observed and evaluated by a tribunal of teachers which will answer to the Board of Judges and to the United States Department of Education. Teachers must be held accountable for the problems that cause students to be left behind.

#### Section 3.1

## **Humanity International University**

Humanity International University will be a global organization of stateOof-the-art computer learning centers which will operate on all college campuses, high schools, middle schools, grammar schools, preschools and day care centers. The following are the objectives for this organization will have for the development of children, adolescent and child students.

- 1. Computer interactive training can be supplemented by certification exams that can count toward college credits and work references.
- 2. Computer tutoring services at these centers can help students that fall behind to have inexpensive and effective remedial programs that can operate during after-school hours including weekends.
- 3. Computer based continuing education programs can make an education a cost-effective reality for adults that still need to earn a general equivalency diploma, a degree, a graduate degree, and/or certificates of achievements and job skills.
- 4. Resume and job placement assistance should be made available to all HIU students. These services should be available to all high school and college graduates before graduation.
- 5. Students may complete surveys where they can evaluate teachers and professors that have given them classes. Students must have the right to hold teachers accountable for abuses of their teaching licenses. The Educational Service Organization has no tolerance for teachers that can give failing grades to college students within their majors.

#### **Section 3.2**

## **Pre-Kindergarten Development Program**

It is important for toddlers to attain the necessary skills that they will need in order to benefit from training in Kindergarten. This program will use computers, video and audio devices to teach kids the essentials of daily living. The objectives are as follows:

- 1. To make sure that the toddlers have a sufficient vocabulary for training in Kindergarten.
- 2. To make sure that the toddlers can speak in complete sentences.
- 3. To make sure that the toddlers can understand the verbal commands, instructions and statements that are made to them by adults.
- 4. To try to teach kids basic socialization skills. This includes saying hello, being friendly and the proper etiquette for eating and being toilet-trained.
- 5. To try to make sure that the toddler can walk for short distances. The toddler should have the ability to engage in at least a minimal amount of exercise.
- 6. The toddler should have the ability to use his/her sensory organs properly as well as his/her hands and arms.
- 7. Toddlers should get a certificate of achievement upon completion of the program. Gifts should also be given as rewards for good behavior.

#### Section 3.3

#### **Elementary Development Program**

The Elementary Development Program will give teachers objectives that students must achieve by the sixth grade. The program will normally start in the first grade. The list of objectives is as follows:

- 1. The students should be able to count from one to a hundred.
- 2. Students should know how to add and subtract numbers. They should also know their times tables and simple division.
- 3. They should know how to read a complete short story to a classroom of classmates in front of their teachers.
- 4. The students should be able to attain acceptable oral and physical hygiene habits. Training should be given to boy and girls.
- 5. Proper feminine hygiene training for adolescent girls should be supervised by school nurses and female teachers.
- 6. Substance abuse training should discuss the consequences of abusing alcohol, tobacco and illegal street drugs.
- 7. Training should be given regarding the danger of using weapons and engaging in violent behaviors.
- 8. Videos of life inside of correctional facilities should be shown to students as part of a child and adolescent crime prevention program.
- 9. Parents should be involved in skill building exercises and computer tutoring programs for kids that fall behind in these efforts to meet their objectives.

#### **Section 3.4**

## **Computer Tutoring Program**

The Computer Tutoring Program will use interactive computer tools and software to assist students that need extra training to meet their educational objectives. These computer centers can also give students a chance to engage in extra credit coursework that will give them extra credits in middle school, high school and college. These centers should be made available to all students regardless it they are from public or private schools. Computer center proctors will assist students in their training in computer centers as well as administering certification and skill building examinations. Results of these examinations will be given to parents and teachers to further asses the student's progress toward meeting teaches' expectations for promotions to higher grades or for graduation from grammar school, middle school or high schools.

#### **Section 3.5**

## **College Prep Development Program**

The College Prep Development Program will try to give emotional and intellectual support to high school student that are preparing to leave home for the first time. This program will operate certification programs that will assure that all students who are accepted into accredited colleges and universities will have the skills and capabilities to succeed in their majors. Career aptitude testing can help students to choose their majors before being accepted into college. Psychological evaluation examinations can be given to students free of charge to make sure that they will get appropriate psychiatric counseling before entering dormitories. This program will also give high school students psychological evaluations upon deciding that they want to attend college.

#### Section 3.6

## **Vocational Certification Programs**

These will be continuing education learning programs that will allow adults to study and practice for a new career or for career advancement by engaging in low-cost computer based vocational training and evaluation by licensed proctors. They can obtain vocational licenses which could be issued by respective government agencies within individual states. These licenses may also be issued by federal government agencies. Licensing examinations can also be given by the proctors of this program at a cost which is consistent with candidates' disposable income and income level. These programs would be available at all Human Services Centers and at all Humanity International University e-schools.

#### **Section 3.7**

## **Continuing Education Programs**

All adults have the right to have or to obtain a high school diploma and a college degree. Humanity International University should have the ability to give adults that work a chance to study for a college degree or a high school diploma in their homes by connecting their computers to the HIU internet access system. They can take final examinations in HIU Continuing Education Centers on all participating college campuses and high schools. This program will also allow inmates in various correctional facilities to work toward obtaining vocational training and certifications that could give them a chance to become taxpayers upon leaving correctional facilities.

## **The Medical Services Organization**

#### Section 4.1

#### **Mission Statement**

The Medical Services Organization is an organization of medical professionals that strive to achieve the goal of nurturing of conception and the indefinite prolonging of human life. The ultimate goal of the Medical Services Organization is to participate in the achieving of the ultimate dream of indefinite and eternal life. The concept of death contradicts the goals and the dreams of out medical professionals. Our goal is to heal all wounds and to prevent the destruction and self-destruction of human life. Humane and top-quality medical care should be given and made available to all individuals regardless of income and social status.

#### **Section 4.2**

#### **The Human Services Centers**

The Human Services Centers will be state-of-the-art computerized facilities that will provide essential medical care to all families and individuals regardless of whether or not they have medical insurance. These centers will provide the following features:

- 1. Pharmacies that will dispense medications to patients at a small copayment. These medications will be ordered from government funded medication warehouses. They will be shipped to Human Services Centers via next-day air.
- 2. Doctors will be available for consultation and all medical emergencies twenty-hours a day.
- 3. Nurse practitioners will evaluate patients to provide reports that can reduce the wait time of patients by forty percent.
- 4. All Human Services Centers will have Humanity International University e-schools. They would provide all of the essential vocational and educational computer systems to aid in furthering the academic goals of their students and clients.
- 5. Psychiatric care will be provided free of charge to all individuals that pose a threat to themselves or a threat to others.
- 6. Psychological counselors will be available for seven days a week to deal with family and behavioral emergencies.
- 7. There should be at least one Human Services Center on every college campus in the United States.
- 8. All programs that are offered by the Human Services Organization will be available through all individuals in Human Services Centers.

#### Section 4.3

## The Pediatric Medical Services Organization

All children deserve top quality medical care regardless of the health insurance status of their parents. The Pediatric Medical Services Organization will be made up of gynecologist, obstetricians, pediatricians and child psychiatrists The goal of these doctors will be to promote and enable the successful conception of human life. They will also try to make sure that our kids will not be a threat to themselves and to others when they mature into adults. These doctors will also attempt to maximize the chances and opportunities that our children will have to participate in the conception and the development of human life as they enter adulthood.

#### Section 4.4

## **The Adolescent Medical Services Organization**

It is the goal of the Adolescent Medical Services will be committed helping our kids to be successful in successfully achieving conception in adulthood. Adolescent doctors and counselors will help our students to deal with all vocational problems that they will encounter as they mature into parenthood. This organization will consist of psychiatrists, psychologists, clinical social workers and parent support therapists that will try to make our kids' transitions into adulthood to be successful and productive to parents, educators and law enforcement agencies. All Human Services Centers will have free and confidential counseling and medical services for all of out teenagers. Family planning workshops can be a helpful effort to help our kids to deal with the stresses of conception and parenthood.

#### **Section 4.5**

## The Adult Medical Services Organization

All adults should have access to essential medical and psychiatric care regardless of their income, health insurance status, age or sexual orientation. Sexually transmitted diseases prevention programs should educate all adults of the dangers and consequences of engagement in high risk sexual behaviors. It should be perfectly clear to adults and adolescents that the Human Services Organization denounces the use of tobacco, alcohol and narcotic street drugs. Law enforcement workshops can educate parents and young adults about the consequences of illegal substance abuse activities. Adults should have access to all public assistance programs regardless of income. Catastrophic health care coverage should be funded by the Human Services Organization through Health Maintenance Organizations when such companies and government bodies can not afford to pay for such treatment. Affordable healthcare benefits should be awarded to small businesses and small companies with realistic and merciful healthcare premiums and copayments for medical services and medications.

#### Section 4.6

#### The Psychological Medical Services Organization

This organization will be responsible for investigating human motivations and behaviors. It is essential that psychologists can conduct research studies in an effort to try to find methods of preventing and mediating the mental conditions that promote the destruction and self-destruction of human life. All adults, adolescents and children should have access to psychological evaluations when a life-threatening crisis arises in their lives. Psychologists should be able to provide public assistance benefits to clients regardless of income. They should be able to determine whether a patient is a threat to himself or herself. The prevention of the eminent effort to destroy or damage human life should be the ultimate goal of psychologists and psychiatrists.

#### Section 4.7

## The Psychiatric Medical Services Organization

All patients that experience the symptoms of behavioral disorders should have access to mental health services either for free or for an affordable co-payment. The Psychiatric Medical Services Organization would be responsible for assuring that all American residents can receive behavioral health services. These psychiatrists can work with psychologists, therapists, nurse practitioners, clinical social workers and family crisis counselors to maximize the chance that the efforts to destroy or damage human life will be averted in their patients' foreseeable future. They can provide a reasonable assurance that patients are not a threat to themselves or others to schools, employers and families when they are voluntary patients.

#### Section 4.8

#### The International Medical Services Continuing Education Organization

This will be an international organization of physicians that will be responsible for training the newest generation of physicians in the United States. They would be responsible that all doctors are kept up to date of all new medical and surgical procedures that can be available to patients that show limited or no response to traditional therapies. All doctors should be trained in how to use the newest therapies which are available to medical professionals. This organization can also administer medical certification examinations as well continuing education certification exams. It is also the responsibility of this organization to strive to make therapies and medications that are available to American doctors to all doctors throughout the world despite any conflicts that the United States may have with such countries and doctors. All citizens of foreign countries deserve their access to all American medical therapies and treatments.

#### Section 4.9

## The Clinical Medical Trials Organization

The future of medicine requires the development of new therapies and medications which can be used for the treatment of medical and behavioral disorders. This organization can reduce the cost of healthcare by subsidizing clinical trials of new medications and surgical procedures. This organization will be committed to making sure that health maintenance organization will be able to provide affordable healthcare to all Americans without being burdened by the cost of the development of new medications, new medical treatments and new surgical procedures.

#### . **Section 4.10**

## The Pharmaceutical Medical Services Organization

This organization would make sure that the medical training that doctors receive from pharmaceutical organizations would not pose an unfair burden on our health maintenance organizations. Doctors should receive training for the use of brand-name as well as generic medication from pharmaceutical organizations. Subsidizing this training can reduce healthcare costs so that medical services can be more affordable to both corporations and government employers.

#### Section 4.11

## The Fountain of Youth Project

This program will investigate aging in adulthood. These doctors will be able to attempt to develop medical treatments that can retard the aging process in adults. This project will attempt to eventually extend youthful looks and fertility throughout late adulthood. It is the goal of this medical project to strive to achieve eternal life for all human beings by the middle of the 21<sup>st</sup> century.

## The Labor Services Organization

#### Section 5.1

#### **Mission Statement**

All taxpayers deserve the chance to exist in workplaces that are conducive to the wellbeing of themselves and their family members. Workplaces should be free of conflict, suffering and tension. All taxpayers should have the right to file grievances against workplaces that have the capacity to cause physical or emotional injury to oneself or to their families. All taxpayers have the right to work with their employers to make sure that corporate America or government employers will heal America's wound while not causing new wounds. The Labor Services Organization will be committed to protecting the rights of taxpayers and to further the cause of healthy management/employee relations.

#### Section 5.2

## The Layoff Delay Program

The Layoff Delay Program will require employers to give at least a six-month notice to employees prior to total termination from a job. Furthermore, these employees will be able to keep their full pay and benefits for at least six months after a layoff notice. The employer would be responsible for sixty-percent of the employee's salary for the six-month period. The Federal Government and the respective state government would provide forty-percent of the employee's salary for the six-month period. The Labor Service Organization can arrange for good references to be given to the employee. The employee would be eligible for vocational training and certification programs which would be operated by Humanity International University. This program will also offer job placement assistance to such taxpayers.

## The Vocational Evaluation and Training Program

This program will help high school students, college students and graduates to assess their potential to perform in various types of careers. This program would start with a series of vocational examinations which would determine if a student or graduate can train for a new career. Placemen in training programs would follow the evaluations. Humanity International University can give adults and adolescents the flexibility that they would need to be trained at Human Services Centers, college campuses or at their home computer workstations in their spare time. This program can especially help workers that have been laid off from their jobs to train for a new career at a very low cost to the government.

#### **Section 5.4**

## **The Grievance Enforcement Program**

All employees of the private sector and of the government can have legitimate grievances against their employers. Such grievances can usually be resolved within an organization. The Grievance Enforcement Program will be operated to resolve grievances that represent the commission of crimes against workers. This program would force employers to release employees with good references and unemployment benefits if the Board of Judges determines that such crimes have occurred. These workers would also be eligible for public assistance programs like food stamps and vocational training programs.

## The Bankruptcy Insurance Program

Personal bankruptcies can paralyze the country's economy. There are times that a taxpayer will have to file for bankruptcy through circumstances that are no fault of their own. Bankruptcies can be caused by catastrophic illnesses that can cause a taxpayer to lose his or her home. Taxpayers that default on their debt can paralyze the economy by causing lender to be severely damaged or destroyed. They following list maintains the aspects of this particular program.

- 1. Bankruptcy insurance should be made available to clients at an affordable monthly premium.
- 2. A multi-billion dollar fund should insure clients against bankruptcy filings that involve catastrophic illnesses and injuries from accidents.
- 3. This catastrophic plan would pay minimum credit card payments and mortgage payments until the illness in effectively treated.
- 4. The client would be allowed to borrow money which would be concurrent with his or her disposable income for the duration of his or her disability or unemployment claim.
- 5. Workers that have been displaced from their employers involuntarily or through the Grievance Enforcement Program would also not be held responsible for his or her minimum payment burden and mortgage payments until he or she has finished a vocational assessment program and has returned to work.
- 6. Upon return to work, the clients would then be held responsible for the mortgage payments and for the minimum payments on their credit cards. They would also be responsible for their Bankruptcy Insurance Program monthly premiums.
- 7. This insurance program can be terminated if the client files for Social Security Disability Income without the intent to return to work. Their debt would then be discharged. They would then be allowed to borrow small sums of money which would be consistent with the disposable income of the client's family.
- 8. Decisions about these issues can be made by the Board of Judges in respective states. All clients should have legal representation at no cost to the client himself or herself provided that their bankruptcy insurance premiums have been paid and are in good standing.
- 9. Email alerts can inform clients of problems with credit cards that are requiring minimum payments that may be inconsistent with the client's disposable income over the next eighteen months.
- 10. The client will have access to his or her credit report at least once a year free of charge.

## **The Business Medical Insurance Program**

Small businesses are just as deserving of having health insurance plans as do the employees of major companies and corporations. The Business Medical Insurance Program will seek to provide affordable healthcare to all employees and their family members of businesses throughout the United States. Premiums for healthcare should be consistent with a business' disposable income. Treatment for these insured individuals should be provided by the Medical Services Organization in Human Services Centers throughout the country. Prescription plans for these precipitants should be managed through these centers. Copayments for medical services and for prescriptions should be consistent with a family's average yearly disposable income.

#### Section 5.7

#### The College Work/Study Internship Program

This program will sponsor college students for yearly internships in government and private sector organizations. College students will be allowed to accrue job experience as students in order to give them a better chance of adjusting to the nation's complex workplaces. Such job experiences can lead to rewarding careers as well as a better opportunity to succeed in the students' first jobs. Thirty to fifty percent of interns' salaries will be provided be the Labor Service Organization.

#### Section 5.8

## The High School Community Service Program

High school student will be able to earn college credits and stipends by participating in after-school community service projects. They will be able to lend a hand to the citizens of their respective municipalities to live better lives. These students could also compete for scholarship awards and special financial assistance for college and for job training and placement programs which would be sponsored by the Educational Services Organization.

## **The Job Placement Assistance Program**

High school and college graduates can receive free resume building assistance by job placement counselor that will be able to assist students in their initial career searches. Displaced workers would also be assisted by these resume and interviewing workshops. A candidate's credentials could be matched against a national database of available jobs. Candidates' resumes can be posted in job banks at the expense of the Labor Services Organization.

## The Legal Services Organization

#### Section 6.1

#### **Mission Statement**

All American citizens have the right to have access to legal representation in front of our county's criminal justice system in times of legal distress. This legal representation should be made available to clients regardless of a client's income or social status. Furthermore, children and adolescents should also have legal representation and counseling free of charge at the expense of the taxpayers. The difference between right and wrong, legal or criminal, and the right path or the wrong path should be plainly shown to our kids so that they will not travel to a road of despair. The Legal Services Organization will provide cost-effective legal counseling and representation to all Americans in all legal situations in our schools, workplaces and our courts.

#### Section 6.2

## The Board of Judges

There should be a Board of Judges that will be able to oversee the activities of the Human Services Organization throughout the United States. There should be legal oversight of all of the programs that will be sponsored by Congress and by the President of the United States. These judges will provide support to the cause of preventing crimes and steering our kids and young adults from the path of injustice. The Board of Judges in every state should be overseen by the state's Supreme Court. A Federal Board of Judges should oversee the activities of the Human Services Organization and the Legal Services Organization in supervision of the individual state's Board of Judges. These legal organizations should ensure that the mission of the Human Services Organization will be achieved in a manner which is legally acceptable to the United States Supreme Court.

#### Section 6.3

#### The Family Legal Services Program

This program will provide legal representation and legal counseling to mothers, fathers, adolescents and young adults that will struggle with complex legal issues. This program will allow families to file criminal complaints and lawsuits against individuals or groups that can commit injustices or non-prosecutable crimes against their family members. The program can also provide low-cost legal representation to low-income families. Lawyers would charge fees which would be consistent with a family's disposable income more than their income in and of itself. No clients should be turned away from benefits because of income or social status.

#### Section 6.4

#### The Adult Legal Services Program

This program would provide criminal, divorce and employment counseling to all individuals who would need such counseling. It is possible that employers can commit crimes and injustices against their employees. Lawyers would protect the rights of adults and would give them legal assistance. Divorce lawyers would protect the rights of fathers, mothers and children during marriage crises. These lawyers would prevent crimes by representing clients who are repentant of their violations by offering public assistance to clients. Fees for such legal services should be based on an adult's disposable income. Special benefits should be awarded to adults that have low income.

#### Section 6.5

## **The Business Legal Services Program**

Small businesses often times do not have adequate resources to seek legal counsel. Lack of legal counsel can cause simple conflicts to escalate to indictments and prosecutions. This program would try to provide legal counseling and guidance to small businesses in order to prevent prosecutions and indictments. The program can also mediate conflicts between businesses and other litigants so that such conflicts will be resolved by peaceful agreement and negotiation. The program's lawyers would provide legal representation to protect the rights of the employees of small businesses.

#### Section 6.6

## The Correctional Legal Services Program

This program will give legal representation to suspects that have the courage to admit that they have committed crimes. Such individuals would have access to public assistance programs that would develop them into taxpayers after they have pleaded guilty to committing non-violent crimes. Suspects that commit violent crimes would have access to psychiatric and psychological counseling in correctional facilities. These lawyers can give access to these programs upon the authorization of the Board of Judges. These lawyers would also mediate legal conflicts between clients and their family members.

#### Section 6.7

#### The Corporate Legal Services Program

The criminal justice system can sometimes overwhelm Corporate America. Simple mistakes can lead to inconceivable crimes that can destroy an entire corporate organization. These crimes can lead to irreparable harm to investors, companies and employees. This program will have lawyers that will work to resolve these conflicts peacefully before they result in indictments and prosecutions. Corporate managers that can have the courage to admit that they have attempted to commit crimes or injustices should receive special counseling and mercy from the Board of Judges. Investors can rely on the Corporate Legal Services Program to make it most likely that corporate indictments can be avoided.

#### Section 6.8

## The Medical Legal Services Program

Families that are victimized by medical mistakes that lead to personal injury often times can be exempted from participation in America's criminal justice system. Doctors can also be victimized by fall allegations in the face of overzealous patients who may seek medical malpractice awards from them. The Medical Legal Services program will help to make sure that families and medical professionals can come to reasonable terms over allegations of medical misconduct. Acceptable compensation should be given to all patients that have suffered verifiable injuries during medical treatment. Medical malpractice premiums can be reduced if medical malpractice insurance companies have this program's lawyers to help them to investigate and resolve complaints against doctors peacefully to the satisfaction of all parties that are involved in disputes. Lawyers can also assist doctors in the process of making agreeable and reasonable admissions about inadvertent or deliberate mistakes while providing medical services to patients.

#### Section 6.9

## **The Probationary Detention Program**

It is difficult for inmates in correctional facilities to be released with any reasonable chance to become taxpayers and to survive outside of incarceration. Some former inmates can have the potential to attempt to recover from a criminal history. The Probationary Detention Program can prevent ex-convicts from being subjected to revolving-door justice that would guarantee a readmission to a correctional facility after being released from one. Probationary detention centers would give inmates a place to live while making the transition from incarceration to freedom. Such program would reduce crimes that may happen after prosecutions and convictions by giving suspects a reasonable chance to escape a life of crime after being released from correctional facilities. They can also give suspects a haven after being caught during the commission of crime. Substance abuse counseling should be provided in all probationary detention centers. All suspects that are admitted into this program will also receive extensive psychological and psychiatric counseling free of charge. They would also have access to vocational rehabilitation programs and educational training. These programs would be overseen by the Board of Judges.

#### Section 6.10

## **The Substance Abuse Prevention Program**

This program would seek to convince children, adults and adolescents to avoid all dangerous controlled substance such as alcohol, tobacco and street narcotics. Counselors would travel to all schools to educate students about the dangers of substance abuse. Monitoring programs can identify substance abuse problems in dormitories and college campuses. Special assistance can be given to college students who see the warning signs of a serious substance abuse problem. This program would encourage high schools and colleges to enforce a no-tolerance for substance abuse policy for all of their students. Television, periodical and billboard advertisement would discourage substance abuse behaviors in adolescents and adults. Special public assistance programs would help substance abusers to recover from episodes involving legal and illegal controlled substances regardless of income or social status. Such programs would be overseen by the Board of Judges.

## The Military Action Organization

## **Section 7.1**

## **Mission Statement**

The Military Action Organization is committed to non-violent conflict resolution through peaceful confrontation. It should be the goal of this organization to prevent violent crime through the peaceful education of individuals that may be at greatest risk for being able to commit such crimes. This organization should treat men and women as equals for the advancement of the of law enforcement's mission to serve and protect the community.

#### Section 7.2

## **MAO Commando Program**

This program will provide food and rent voucher to individuals that turn in their guns and weapons to special MAO-ATF Commando Units. These commandos will protect the community by working with school and community leaders to convince kids that guns only work to get you jail time. The commandos of this program will work to reduce violent crimes by identifying and helping adolescents and young adults that would benefit from psychiatric, psychological and vocational counseling because of their propensity to commit acts of violence. This organization believes that preventing crime by helping suspects to live without having to commit crimes is the best form of crime prevention.

#### Section 7.3

## **Corps of Adolescents**

Adolescents are not taxpayers that can automatically know that difference between right and wrong. Special organization of adolescents can oversee problems within our schools which could eventually threaten the community. The Corps of Adolescents will be an organization of young adult commandos which will help to stop violence in our schools. These young men and women should set an example to kids in our schools by being responsible with their behaviors, sexuality, relationships and commitment to the community and to the advancement of the effort to serve and protect the community. They would be trained at special boot camps that will give them the training to serve their schools and communities. They would get a stipend for every year that they serve while in their schools.

#### Section 7.4

## **MAO College Commando Patrol**

This program will gather intelligence about potentially life threatening problems within our college campus communities. These covert operatives will report to the federal government, local law enforcement agencies and the United States Department of Education. There is a possibility that students on college campuses can become a threat to themselves or a threat to others. These College MAO Commandos will seek to find these individuals in dormitories and in college social events. The goal of this will be to seek and to give psychiatric and medical attention to such students. It is imperative that destructive and self-destructive behaviors be prevented peacefully through damage control operations within our schools of higher education. Public and private schools should be given financial assistance to conduct such programs in their respective schools.

#### Section 7.5

#### **MAO-DEA Commando Program**

It should be the goal of the Military Action Organization to prevent substance abuse in our schools and communities. The MAO-DEA Commando Program will consist of adults and adolescents that will give assistance to individuals who are at high risk for succumbing to abusing illegal street drugs, tobacco and alcohol. These commandos will try to gather intelligence that can help doctors and community leaders to understand how better to treat substance abuse problems within our population of adults and adolescents. Peaceful intervention in a potential substance abuser's life is more productive than afterthe-fact justice.

#### Section 7.6

## **MAO Anti-Gang Commando Program**

This program will have operatives that will be able to infiltrate gangs in municipalities. Gang members will be offered vocational training, psychiatric counseling, and access to public educational assistance program and internships that will condition former gang members to be taxpayers. Gang members will be required to turn in their weapons to MAO-ATF commandos in exchange for access to public assistance programs. Psychological and family counseling will be provided for families that have been victimized and infiltrated by gangs.

#### Section 7.7

#### **MAO Commando Urban Guard**

Numerous disasters can befall a community at a moment's notice. An instantaneous upsurge in violence and anarchy can paralyze local law enforcement agencies. A natural disaster may be catastrophic. The MAO Commando Urban Guard will be activated at a moment's notice to assist emergency management personnel and local law enforcement agencies in the event of a catastrophic failure. Commandos would answer to local, state and federal emergency managers. They will have special training and resources to stage a rapid response to a perilous local nightmare. The MAO Commando Urban Guard will be waiting and prepared for the worst. They will also be prepared for a rapid recovery from chaos and peril.

#### Section 7.8

#### **MAO Housing Commando Program**

A local disaster can leave families in a state of homelessness in a moment. A family crisis can leave men, women, adolescents and children with nowhere to stay after a domestic violence incident. Low income housing projects can deteriorate into insanity when gangs and criminals infiltrate the lives of innocent men, women and children. The MAO Housing Commando Program will provide humane emergency housing facilities for families and family members which are displace by a domestic dispute or a natural disaster. The housing commandos will insure that families in housing projects will be safe from harm. Housing assistance programs should be an integral part of any universal healthcare program.

#### Section 7.9

## **MAO-United Nations Conflict Mediation Program**

International conflicts can paralyze the Department of Homeland Security and the Department of Defense. Peaceful confrontation can provide a means of avoiding armed conflict. Peaceful negotiations can stop bloodshed and mortality. The MAO-UN Conflict Mediation Program would work to identify the source of life threatening conflict throughout humanity. The MAO-UN Commandos would be specially trained to analyze and to respond to racial, ethnic, religious or prejudicial conflicts that would encourage and promote violence as a way to resolve conflict. MAO-UN commandos would work closely with the United Nations to prevent eminent bloodshed and suffering. Such a program should be funded by any universal healthcare program.

## The Political Action Organization

#### Section 8.1

#### **Mission Statement**

The Political Action Organization will strive to preserve the integrity of America's electoral procedures. This organization should make a strong effort to keep the American people informed of matters which concern the appointment of elected officials in public office. Candidates for elected office should be showcased in special local television stations as well as on local radio stations. All candidates who want to serve the American people in public office should get equal and fair consideration regardless of their income or social status. Such individuals should be provided with special training and guidance so that they can adhere to very strict ethical standards of public office.

#### Section 8.2

## The Municipal Leaders Development Program

This program will develop candidates that will serve in elected an appointed municipal and county government positions. These candidates will be provided with publicity and equal treatment as would all candidates that will be competing for public office. Candidates should take training and development seminars that will show how they can perform their jobs to them. Certification exams can give candidates a special advantage that will allow them to serve their communities.

#### Section 8.3

## The State Leaders Development Program

This program will groom candidates for public service in state governments and as state leaders. Certification exams would include such topics as U.S. History, the history of the state, aspects of the Constitution of the United States that pertain to state governments and aspects of their own state constitution. Training seminars for preparation for employment by state governments can be given to candidates at local college campuses or through a Humanity International University e-School. Candidates should be trained to uphold the highest ethical standards in their jobs.

#### Section 8.3

## The Federal Employees Leader Development Program

It is important for the Human Services Organization to assist candidates for federal employment and for federal elected positions to have access to training in development that would help them to serve the American people and the human race in a way that is constructive. The importance of employing top-quality federal employees is imperative for the stability of our democracy and for up keeping of our status throughout the world. All Human Services Centers would have resources to train and develop federal employees.

#### Section 8.4

## The Federal Public Relations Program

This program would conduct scientific polls on the internet, by phone and by text messaging services. These polls will sample a wide range of topics and opinions that are held by the American people. The integrity of the data from the polls would be monitored by central computer systems so that the results of polls would not be corrupted. The results of polls should be made known to the American people through our news organizations free of charge. Assuring that the American people can stay informed about their opinions can further the cause of democracy in America. It is also important for our leaders to know where the American electorate stands on the wide range of issues that affect all Americans.

#### Section 8.5

## The Federal Electoral Ethics Enforcement Program

All federal, state and local officials should adhere to strict ethical standards before appearing as candidates for public office. The Federal Electoral Ethics Committee will train candidates to understand the law and to practice prudence in the way that they will carry out their duties as elected officials. Scandals can be seen well into the future and damage control operations can insure that an elected official's remorse for possible violations of laws or ethical standards can prevent the malicious campaign of crimes that can lead to the demise of the government. Lawyers for this program would screen all candidates for criminal histories to insure that our elected officials are trustworthy taxpayers could be depended upon in times of duress and hardship for the American people.

## The International News Organization

#### Section 9.1

#### **Mission Statement**

The American Democracy is based upon the notion that free speech and freedom of the press should preserve the freedom and well-being of the American people. The American people invest vast amounts of money to support our news organizations. News organizations have a responsibility to report news in a timely manner while observing the highest ethical standards. The Government of the United States of America can not participate in state-sponsored news casting. It is, however, prudent for our news organizations to be preserved by government subsidies and by organizations that will set ethical standards that will prevent corruption within our news organizations. Americans deserve journalism that is responsible, comprehensive and constructive. The International News Organization would be an independent organization of journalists that would work with private news organizations throughout the world to report news that promotes life and not death and destruction.

#### Section 9.2

#### The International Association of Journalism

Training journalists can be a daunting task for our colleges and universities. Today's news organizations are driven by computers and complex communication systems that were not available just a few years ago. Journalists should be able to attend seminars and training workshops that would allow them to function to the highest standards of journalism. Certification examinations can give our journalism students a chance to obtain real-world skill as well as the ability to show that they have acquired those skills. Ethical standards for journalism should be established and enforced by a tribunal of journalists that would keep our news organization in check with their jobs. The International Association of Journalism would subsidize and supervise our news organizations to make sure that they would always have the resources to report constructive news about the goodness of humanity.

#### Section 9.3

## **Humanity Weekly Magazine**

Humanity Weekly Magazine would show the positive side of a human race that is in turmoil. All networks should have access to various versions of this magazine's reporters, broadcast journalists and producers. These programs would assist news organizations that would find themselves in financial peril. It is important for news organizations to have positive news to report all of the time. The progress of the Human Services Organization should be headline news for all Americans.

#### Section 9.4

## **Humanity Weekly Kids' Magazine**

An international news organization would be devoted to covering all news that would be pertinent children and adolescents. Adolescents would be journalists and reporters in training which would work as interns in various capacities. These programs would act as resources for parents and educators that struggle to understand adolescent issues. Kids would take center stage in a world that would be dominated by adults.

#### Section 9.4

## **Humanity International Weekly Magazine**

The first step that Americans have to take in understanding the problems of human beings in other parts of the world is to learn about the problems. Likewise, other peoples throughout the planet should understand issues which confront the federal government and the American people. Transmitting such newscasts can be extremely expensive and unrealistic. Humanity International Weekly Magazine would subsidize international broadcasting on positive news about humanity in the United States and throughout the world.

## The Future of Humanity

We all hope to find ways to end suffering and despair for all human beings throughout the world. All human beings should work with our respective governments and with the United Nations toward furthering the goals of our world's religions. All nations must have a constructive relationship with God in order to survive during our daily struggles. We all have a commitment to God to promote his ability to conceive and to support human life. The destruction of life is incompatible with the laws of all the nations of the world. We should always pray for the strength to deal with our problems with God's help. Our governments should not be so detached from the peoples that they serve and represent. The Human Services Organization may be formed to help our governments to have multitudes of resources to further God's cause of conceiving and preserving all life both here and throughout the universe.
