What's going on in the Office?

The Sheriff joins the Douglas County Educational Foundation Board of Trustees. At the January 28th board meeting Sheriff Weaver was unanimously approved to serve on the Board as one of the Trustee Members. The Douglas County Educational Foundation (DCEF) was created in June of 1990. The purpose of the Foundation is to develop private resources to enrich education within Douglas County schools for the fulfillment of lifelong learning experiences of our students, citizens and community.

Douglas County residents can now take their neighborhood crime map with them wherever they go. The new iPhone application will provide citizens with local crime mapping and national sex offender data. The Sheriff's Office already publishes their crime data on the National Crime Map at www.CrimeReports.com and is now making that data even easier to access through the CrimeReports iPhone app. The link is also available on the Sheriff's Office website, www.dcsheriff.net, under the Crime Statistics link.

Coplogic Online Citizen Reporting. Today when a citizen wants to report a misdemeanor crime they have two choices; call for an officer to respond, or download a form off the internet from our website and print it out and fax it in. Soon, citizens will have a new choice; filling out the report electronically using an application called **Coplogic**. This system asks a series of questions that limit what type of crimes can be reported electronically; if the crime committed has a suspect, if the crime is a felony, if the item stolen is a firearm, or if the crime did not occur in unincorporated Douglas County. If they answer yes to any of those they have to call an officer to respond and take the report or call a different jurisdiction. After the citizen completes the online report the patrol supervisors will either approve or reject the report. If the supervisor rejects it, the citizen gets an email telling them they need to fix their report, or call the office for an officer to respond.

Some agencies have seen a 60% reduction in officer response once Coplogic was activated at their department freeing up patrol officers to concentrate on crimes in progress or felony crimes. February 2010

COMMUNITY MEDIATION PROGRAM

Community MEDIATION:

The Douglas County Sheriff's Office has entered into a contract with **Community Mediation Concepts** to provide community mediations and citizen-officer complaint mediations. Community Mediation *Concepts* (CMC) is a nonprofit community mediation organization contracting with Douglas County Sheriff's Office to provide mediation and conflict resolution. Community Mediation Concepts uses professional mediators to assist people in coming together to address concerns, increase awareness / knowledge and find solutions agreeable to all parties involved. Community mediation includes disputes between neighbors

regarding pets, noise, property maintenance, landscaping issues, and other neighborhood issues; disputes between residents and landlords, homeowners associations regarding residential code or zoning Citizen / Police Mediation is a Community mediation violations. assists disputing parties in resolving the relevant concern and to achieve a more productive level of communication. Mediated resolutions decrease the need for law enforcement and judicial agency intervention.

Mediation is a process of cooperative and respectful communication based upon the following key principles:

Safe environment Neutral and impartial facilitation

CITIZEN/ POLICE MEDIATION:

voluntary and confidential process in which a professional mediator helps community member(s) and police officer(s) talk and listen to each other. It is a chance for officers to hear how their actions affected community members and for community members to better understand the actions of the officer. Mediation provides an alternative to the traditional complaint and disciplinary process in Douglas County.

He was elected as your Douglas County Sheriff in November 2006, but actually began his outstanding service career at the Douglas County Sheriff's Office in 1981.

During his 28-year career, he promoted through the ranks and has served in nearly all areas of administration and operations, including the Detention Division, Patrol Division, Internal Affairs, and as the Undersheriff. Most recently, he implemented the new Internet program <u>CrimeReports.com</u> so citizens can easily get information about crime in their areas and, he created the Text-a-Tip program so high school students can easily and discreetly provide cell phone text message tips about student safety issues.

Above and beyond his Douglas County duties, Sheriff Weaver is very dedicated to community service and helping the law enforcement profession. A former Parker Rotarian and Castle Rock Kiwanis Club member, he also demonstrates his commitments through service on the Colorado Automobile Theft Prevention Board, Colorado Identity Theft Board, the National Association of Counties Justice & Public Safety Steering Committee, and the County Sheriff's of Colorado Board of Directors. He also helps the National Sheriff's Association by serving on their Crime Victim's Advisory Board and Committee for Ethics, Standards, and Accreditation.
