What particular action, by the City or its employee(s), caused the alleged damage or injury? Continued conspiracy among numerous city employees to cover-up abuse by James Roberts. Negligent hiring and supervision of employees by City and City employees. Violations of officer domestic violence policies. Failure to report incidents and failure to discipline Roberts. Assault and Battery.
