- Podcasts video or flash-enhanced, narrated presentations for benefits learning such as during annual enrollment or ongoing for wellness and benefits awareness.
- Compliance section for SPDs, SMMs, benefits brochures, carrier materials, etc.
- Links to other centers of learning (i.e., carrier's Web sites, wellness sites for health management, etc.
- Email and chat live capabilities to connect with your benefits representatives or service center.
