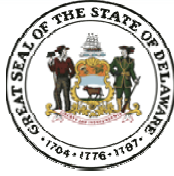


Client Success Story: Security for Cash Management

State of Delaware's Goal

The Department of Finance at the State of Delaware approached SmartERP with the significant goal of enhancing their PeopleSoft Financials with increased security features spanning Data Entry and Inquiry pages, including:

- Security at the Department level to enforce confidentiality and privacy in Cash Management
- Security scope that spanned data entry pages, access to reports, inquiries, and queries
- Security settings that are dynamic, enabling different application areas to have different security contexts
- Extensibility—to readily accommodate future security needs

Challenges

- Securing data at the Department Level was unavailable in standard PeopleSoft
- Having consultants pursue one-off customizations was untenable due to development and ongoing maintenance costs
- Standard functionality only provided for static security, applied equally across the entire system—essentially one context for all users across all areas
