Hoang participated in patrols and raids that disrupted insurgent leadership networks in Southeast Afghanistan. He also spearheaded legal efforts that led to the successful long-term detention of captured insurgent leaders, as well as projects to improve schools and deliver school supplies.

Hoang graduated in the academic top 1% of his class from the United States Military Academy, earned a Master of Criminal Justice degree from Washburn University, and graduated *magna cum laude* from Georgetown University Law Center. Hoang also passed the CPA Examination in the District of Columbia. Hoang served as a Judicial Law Clerk to the Honorable Thomas B. Griffith of the U.S. Court of Appeals for the D.C. Circuit and as a Law Clerk to the Honorable Jamie Baker of the U.S. Court of Appeals for the Armed Forces. A native of Tumwater, Washington, Hoang, along with his family, was evacuated from Saigon, Vietnam at the age of two.
