### Highlights of Contributions to Islamic Finance

Year	Highlights
1963 - 1967	First modern experiment with Islamic banking – the pioneering effort, took the form of a savings bank based on profit-sharing in the Egyptian town of Mit Ghamr. The project later became part of Nasr Social Bank and eventually spurred the opening of nine similar Islamic Banks in Egypt.
1972 - 1975	Played a leading role in an Egyptian study on an Islamic financial system which laid the foundation for the establishment of the Islamic Development Bank which funds projects in member countries.
1974 - 1975	Head of Economic Division to the Conference of Islamic Ministers, Jeddah
1975 - 1977	Professor of Islamic Economics at the King Abdul Aziz University, Jeddah
1977 - 1994	Secretary-General of the International Association of Islamic Banks
1981 - 1984	Founded the International Institute of Islamic Banking and Economics in Northern Cyprus to cater for the intellectual and operational needs of their Islamic Banks
1983	Founded the Kibris Islamic Bank
