SAS 70 defines the professional standards used by a service auditor to assess the internal controls of a service organization and issue a service auditor's report. A Type II service auditor's report includes the service auditor's opinion on the fairness of the presentation of the service organization's description of controls that have been placed in operation and the suitability of the design of the controls along with the auditor's opinion on whether the specific controls were operating effectively during the period under review.


