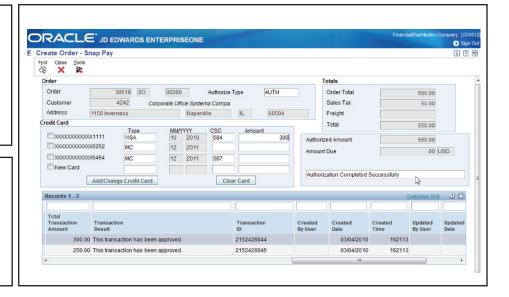

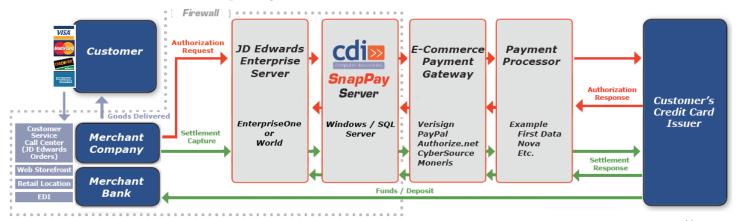

- Credit Card Data Stored Encrypted in JDE F55 Custom Tables
- Credit Card Data Transmitted Encrypted
- Optional Ability To Store Credit Card Data Off-Site
- Option to Automatically Delete Credit Cards After Use
- Credit Card Numbers "Masked" Permanently

A/R Collection Tool - for CSR's, Finance & Accounting

- Pay Open A/R Invoice(s) with a Credit Card
- Allow for Full or Partial Payment Against Invoice
- Initiates Automated A/R Batch Receipt Process

Batch A/R Update - Clear Open A/R

- Automated "A/R Receipt Batch" Process applying "Case Receipt" based on Credit Card Payment
- Updates Open Amount & Pay Status with Receipt Transaction(s)
- Pro-Active Email Alert / Notification with Batch A/R Update
