SAS 70 Type II

DataBank IMX has received an unqualified SAS 70 Type II opinion from RSM International (McGladrey & Pullen) the sixth largest accounting firm in the world and one of the nation's leading providers of audit and attest services.

SAS 70 is an acronym for Statement on Auditing Standard 70; it was developed and is maintained by the AICPA (American Institute of Certified Public Accountants).

Type II audits are more thorough. Auditors test the efficacy of internal controls to reasonably assure that they are working correctly; they document their findings and present their opinion on the effectiveness of all controls. Type I only lists the controls.

DataBank IMX's SAS 70 Type II covers document handling operations, document imaging, data management, and internal and vendor document image transmission as well as a comprehensive set of internal operating processes.

Physical Security

DataBank IMX's Production Centers are monitored 24 hours a day, 7 days a week by the nation's largest security company ADT. All access is logged and tracked, and requires two forms of credentialing (Photo ID Badge and PIN Code combination).

Server rooms are further protected with intrusion/heat/fire/water detection systems.

Data Security

All of our facilities are interconnected in a Private WAN (Wide Area Network). Traffic is managed by MPLS (Multi Protocol Layer Switching) thus providing improved performance and reliability. Our private WAN is managed in conjunction with our technology partner, Verizon Business.

We use our SecureTransport software suite, a leading solution for managed file transfer. SecureTransport moves billions of dollars in financial transactions daily and 8 of the top 10 U.S. banks use it to serve tens of thousands of corporate customers.

PCI is a security standard (originating in the credit card industry) that includes requirements for security management, policies, procedures, network architecture, software design and other critical protective measures.


