

IDENTEC GROUP ACQUIRES HOTHEAD TECHNOLOGIES

Appoints Industry Veteran, Peter Linke, as CEO.

DALLAS, TEXAS – May 2, 2011 – IDENTEC GROUP AG, the leading global RFID solutions provider, has acquired 100% of Hothead Technologies, Inc., it was announced today by both companies. Prior to the acquisition, IDENTEC GROUP had a 5% stake in the award-winning, Dallas-based provider of wireless sensor solutions, which now becomes a wholly owned subsidiary.

In conjunction with the acquisition, Peter Linke, an industry veteran with a long track record of successfully growing high technology companies, was appointed President and CEO of Hothead Technologies. Prior to the appointment, he served as President, Americas of IDENTEC SOLUTIONS, Inc. (<http://www.identecsolutions.com>), one of nine IDENTEC GROUP member companies providing RFID solutions around the world.
