Natural High Contest

Official Rules

Please read these Official Rules ("Rules") carefully before participating in the Natural High Contest ("Contest"), sponsored by the Sundt Memorial Foundation ("Sponsor").

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Participation in this Contest is strictly online and entries may be received only as outlined in these Rules. Entries will be accepted only by following the instructions on http://www.naturalhigh.org/contest. See "How to Enter" for additional details.

1. ELIGIBILITY

Contest participants must be (a) permanent legal residents of the United States and (b) at least 10 years of age and no greater then 18 years of age at the time of entry. This Contest is void outside the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. This Contest and any advertisements relating thereto are intended for viewing only within the 50 United States and the District of Columbia. By participating in the Contest, you agree that: (1) you have read and understand the Rules; (2) you meet the Contest eligibility requirements as explained in the Rules; (3) you are bound by the Rules and to Sponsor's Conditions of Use, Legal Notices and Privacy Policy as published in the Rules; (4) you unconditionally accept and agree to comply with and abide by the Rules and the decisions of Sponsor; and (5) the Rules shall be legally binding on you and your legal representatives, heirs, successors, and assigns.

Persons in the following categories are NOT eligible to win prizes in the Contest: the Sundt Memorial Foundation or any of their, subsidiaries, affiliates, retailers, and advertising and promotion agencies, and vendors involved in this Contest (collectively, "Contest Entities").

2. HOW TO ENTER

To enter the Contest, visit http://www.naturalhigh.org/contest and follow the instructions to create your submission between September 1, 2010 at 7:00 a.m. PST and March 31st, 2011 at 11:59 p.m. PST. Create a submission for the Contest by participating in 1 of the following 5 categories:

1) Videos/Broadcast/PSA - Make a video about your natural high. In the video, make sure to include the following points: 1) What your natural high is and how it makes you feel 2) How you discovered your Natural High 3) Peer influences, values or role models related to your natural high 4) How using drugs and alcohol could keep you from pursuing your natural high to the fullest.

- Size: 1-3 minutes in length
- Format: Upload the video to YouTube and simply send us the URL link to view it via email or mail. OR email us the original video file in QuickTime .MOV, Windows .AVI, or .MPG format. We specifically recommend the MPEG4 (Divx, Xvid) format at 640x480

resolution with MP3 audio. You may also mail us a disc but video file on the disc must still be in one of these formats.

2) Poster Art - Make a poster related to your Natural High (It can be a drawing, painting, photo collage, or a combination of all 3. In the poster, make sure to show: 1) What your natural high is and how it makes you feel 2) How you discovered your Natural High 3) Peer influences, values or role models related to your Natural High 4) A quote from you on how using drugs and alcohol could keep you from pursuing your natural high to the fullest.

- Size: Minimum size 8 1/2" x 11" and no larger than 18" x 24"
- Format: Submit in JPEG or PDF format (if emailing) or any format through mail.

3) Writing/Journalistic - Submit an original writing piece on either of the following topics. In your piece, make sure to identify: 1) What the natural high is and how it makes the person feel 2) How the natural high was discovered 3) Peer influences, values or role models related to your Natural High 4) How using drugs and alcohol could affect you (or others) from pursuing a natural high to the fullest.

- a) Write an essay about your own natural high.
- b)Write a report on a drug free person. Identify a role model, either famous or in your own life, that pursues a natural high and lives a drug free life. Research the person either in person by interview, or on the Internet.
 - Size: 500-800 words
 - Format: Submit in DOC (word) format if emailing, or a hard copy if mailing

4) Performance - Write and perform in front of the class a poem, song or rap expressing what "living naturally high" means to you. In your piece, make sure to include: 1) What your natural high is and how it makes you feel 2) How you discovered your Natural High 3) Peer influences, values or role models related to your Natural High 4) How using drugs and alcohol could keep you from pursuing your natural high to the fullest.

- *Size: 200-400 words*
- Format: Film your performance in front of a live audience and either upload the video to YouTube and simply send us the URL link to view it via email or mail, OR email us the video file in QuickTime .MOV, Windows .AVI, or .MPG format. We specifically recommend the MPEG4 (Divx, Xvid) format at 640x480 resolution with MP3 audio. You may also mail us a disc but video file on the disc must still be in one of these formats. Also include a written copy of your piece in DOC (word) format if emailing, or a hard copy if mailing your submission.

5) Presentation - Give a speech about your Natural High and create a 5-10 page power point to go with it. Include in your speech: 1) What your natural high is and how it makes you feel 2) How you discovered your Natural High 3) Peer influences, values or role models related to your Natural High 4) How using drugs and alcohol could keep you from pursuing your natural high to the fullest.

- Size: 4-5 minutes in length
- Format: Film your presentation in front of a live audience and either upload the video to YouTube and simply send us the URL link to view it via email or mail, OR email us the original video file in QuickTime .MOV, Windows .AVI, or .MPG format. We specifically

recommend the MPEG4 (Divx, Xvid) format at 640x480 resolution with MP3 audio. You may also mail us a disc but video file on the disc must still be in one of these formats. Also email your powerpoint presentation, or include a hard copy of the pages if mailing your submission.

When done, fill out the Natural High Contest Registration Form and send in (along with your submission) via one of these following methods:

You agree that all videos, images, and materials that you submit or transmit are owned solely by you and that you assume total and exclusive responsibility and liability for the content thereof and the use thereof. The Sponsor has the right to use your video on their websites as well as for marketing purposes for an unlimited time frame. You also agree that you will not upload or post any videos or other content that is or may be threatening, profane, harassing, defamatory, unlawful, vulgar, obscene, pornographic, libelous, invasive of another's privacy, hateful, or racially, ethnically or otherwise objectionable, or which may give rise to civil or criminal liability under any applicable law. You further agree that you will fully indemnify and hold the Sponsor harmless of, from and against any liability, loss, damages, costs and attorneys fees that may be alleged against or incurred the Sponsor as a result of any and all claims by third parties or law authorities related in any manner to your videos and materials or the use thereof regardless of whether or not the Sponsor pre-screens your content. The Sponsor reserves the right to edit or remove content at their sole discretion for any reason.

Complete entries can be submitted to the Contest at any time during the contest. Sponsor will attempt to notify winners by April 15, 2011 using the e-mail address and other contact information provided on contact form. If after five (5) days from the first attempted contact Sponsor cannot reach or does not hear from a prize winner, such winner will not be eligible to receive a prize and his/her prize may be, at the sole discretion of Sponsor, forfeit, or given to another entrant chosen on the basis of the same criteria described in the "How the Winners are Determined" section of these rules.

Sponsor is not responsible for lost, late, incomplete, stolen, misdirected, or illegible entries, and entries will only be accepted with the completion of the entry form found at http://www.naturalhigh.org/contest. Once submitted, your entry cannot be edited or deleted from the Contest. Only complete entries will be accepted.

NOTE: Entrant may be required to provide Sponsor with proof that he/she is the authorized account holder of the e-mail address associated with the entry. If a dispute cannot be resolved to Sponsor's satisfaction, the entry will be deemed ineligible. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including commercial

sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified from this Contest. The use of any device to automate the entry process is prohibited.

3. PRIZE DETAILS

(1) \$250 Natural High Scholarship will be awarded per entry category, per Judging Level (see Judging Levels in "How the Winners Are Determined. There will be (10) Prizes awarded total. A Natural High Scholarship Prize can be used towards anything that furthers an individual's participation in their Natural High!

4. HOW THE WINNERS ARE DETERMINED

Submissions will be accepted in the Contest, in accordance with these Rules, from September 1, 2010 at 7:00 a.m. PST through March 31st, 2011 at 11:59 p.m. PST. There will be (2) Judging Levels based on grade level. The first Judging Level is for Middle School Students (grades 5th-8th) and the second Judging Level is for High School Students (grades 9th-12th).

After the conclusion of the Contest Period, entries will be judged using the "Judging Criteria" by the Sponsor. The Judges will make this decision based upon the following criteria: (25%) creativity; (25%) quality; and (50%) answer of questions and fit with overall natural high theme ("Judging Criteria"). The Entries that receive the highest score, as determined by the Judges, will be the potential Featured Winners, now eligible for the Natural High Scholarship Prizes. In event of a tie, the Entry from among those tied with the highest score in the overall message fit with theme criterion will be deemed the potential Featured Winner for that particular Prize Category.

5. ODDS OF WINNING

The chances of winning a Prize will depend on the number of eligible entries submitted. In the event any Prize Winner cannot be contacted as specified in these Rules, or does not otherwise comply with all the requirements set out in the Rules, he/she will be disqualified.

6. USE OF PERSONAL INFORMATION AND E-MAIL ADDRESSES

In the event you are not already receiving Natural High updates at the e-mail address you provide at the time you submit your Contest Registration form, you will automatically be signed up to receive Sponsor's free monthly Natural High Newsletter. The newsletter features information about products, resources, news, and events regarding Natural High and the Natural High ® DVD Series. Once signed up to receive the newsletter, you may opt out of receiving it by selecting so at the bottom of any Natural High Newsletter that you receive. Opting out of receiving the Natural High Newsletter will not increase or decrease your chance of winning the Contest.

Sponsor is not liable or responsible for any content provided by users of this Contest and Sponsor's websites; <u>www.naturalhigh.org</u>, <u>www.naturalhigh.tv</u> and <u>www.sundtmemorial.org</u>.

8. PRIZE RESTRICTIONS

Prizes will be awarded only to winners who have fully complied with these Rules. Prizes are awarded "as is" with no warranty or guarantee either expressed or implied. Sponsor credits are subject to terms and conditions specified by law and apply only to video fulfillment products and not related shipping and handling. Sponsor reserves the right to substitute any prize for one of comparable or greater value, at its sole discretion. Winner is solely responsible for all federal, state and local taxes, including any income and withholding taxes, as well as all other costs or fees associated with acceptance and/or use of the prize not specified herein as being awarded.

9. CONTEST CONDITIONS

This Contest is subject to these Official Rules and all applicable federal, state, provincial and local laws and regulations (collectively "Rules and Laws"). Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the

operation of the Contest; to be acting in violation of the Official Rules, or to be acting in a nonsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person; and all associated entries will be void.
