

Becoming a Member

Membership Information

- Refundable Equity Membership entrance fee is 80% refundable
- Membership is transferable to your heir without an entrance fee
- Complimentary associate membership for your spouse/partner and dependent children
- Guest membership at an international network of reciprocal country clubs
- No minimum monthly spending requirements
- Entrance fee of \$5,000 is due with application, and financing is available

- Regular, Non-Resident, Junior & Neighbor Island memberships have unlimited complimentary golf, tennis, fitness center and pool privileges.
- Regular Members have the exclusive right to vote and hold office.
- Non-Resident privileges extend for six months each calendar year.
- Social membership has unlimited use of golf course and tennis courts. Social members pay \$21 for 9-holes and \$40 for 18-holes for golf; \$10 per day for tennis.
- Neighbor Island applicants must reside in the State of Hawai'i, but may not reside on Maui.

Refundability

- The amount of the refund is 80% of the current entrance fee at the time of resignation. The refund will be made within 30 days after the reissuance of the resigned membership.
- A resigned Refundable membership will be placed on a waiting list by class of membership and will be reissued on a first-resigned, first-reissued basis as follows:
 - 1. The Club will reissue the Refundable membership on the resigning member's behalf to an incoming member.
 - 2. Prior to the sale of all Refundable memberships in a particular class, every fourth membership issued in that class will be a resigned membership.

Transferability

- A member may transfer membership at any time to a spouse, an adult child or grandchild without any added cost (subject to approval).
- The Refundable membership automatically transfers to the surviving spouse of a deceased member with no additional entrance fee.
- If the deceased member is not survived by a spouse, then the heir will have the right to acquire the deceased member's membership with no additional entrance fee.
- The application must be filed within 90 days after the death of the member, and all unpaid dues, entrance fees, charges and assessments are payable.
- A member may not transfer or sell his or her membership to any person or entity.

Application Process

- All requested information is completed including the applicant's signature. By signing, the applicant acknowledges that he/she accepts the membership hereunder, and will be subject to the By-Laws and rules of the Club as then in force and thereafter made or amended, as applies to his/her classification of membership.
- Two members of the club are required as sponsors, one as a Proposer and another as Seconder.
- A current photo, preferably digital sent as an email attachment to luana@mauicountryclub.org.
- Entrance fee (payable by check, as cash is not accepted). In the case of 50% entrance fee financing, please include the signed Addendum.
- During the approval process, the applicant may use the Club facilities and pay fees associated with the Social Membership.

Process of Approval

- Applications are posted for two weeks to allow for membership review. In the event that objections are received from the membership during the posted period, the application shall be referred to the Membership Committee for investigation.
- Following the two-week posting, the Membership Chairperson will call for a meeting with the Proposer and the Applicant.
- The membership committee will then meet to determine their recommendation for presentation at the Board of Directors meeting.
- The Board of Directors meets on the fourth Thursday of each month. Acceptance is determined by majority vote.
- Applicants will be notified of acceptance.
- Membership is effective the first day of the month following approval.
