The Outcome: The Transition DPT Program is designed so that graduates will:

#### **Admission Requirements**

- All applicants must provide a copy of a current and valid license to practice physical therapy in one of the 50 United States, the District of Columbia, Puerto Rico, or US Virgin Islands. This license must be in good standing.
- 2. All applicants must be active members of the APTA and in good standing.
- 3. All applicants must have successfully completed a CAPTE accredited professional physical therapy curriculum, or have had a state physical therapy board approve the applicant's first-professional physical therapy program as "equivalent" to a US CAPTE accredited professional physical therapy program.
- 4. If English is not the applicant's native/first language, specified language proficiency requirements must be met.
