It was determined that Pearl had developed complications and that treating these complications would make it impossible to treat for the stroke as well. When Pearl would no longer eat, Victoria's family had to make the agonizing decision to put Pearl to sleep.

Even though he was on vacation, Dr. Eubank left his family to go to Victoria's home and help them through this terribly difficult process. Dr. Eubank's bedside manner was exactly what the family needed; giving them time to come to grips with their decision, say their goodbyes, and assuring them that they did everything they could to help their beloved dog.
