Seventh Grader Slams Competition

13-year-old wins \$1,000 during Joye Law Firm's 8th Annual Shoot Three and Win Challenge

NORTH CHARLESTON, S.C. (Jan. 12, 2012)—Most coaches will tell you that basketball games are won and lost at the foul line. I thought my chances of winning were pretty slim," said Ian, who was in town from Maryland visiting his grandmother and decided to attend the basketball tournament with his dad.

Facing several thousand audience members on the final night of the tournament, Ian outshot 12 participants before going head-to-head with his last opponent. The two went five rounds until Ian's opponent missed his shot, and Ian then drained his shot.

"The final night of the challenge resulted in several rounds of 'shoot or die' before Ian won it, and, as a result, the crowd was really into it," said Joye Law Firm attorney John Decker. "I was honored to be part of the event and to present Ian with his first place prize on behalf of the firm. He is fine young man, and if he keeps practicing, maybe someday he'll be playing in the tournament."
