Keynote Speaker

Dr. Gene Abel is the Director of Research at Abel Screening, Inc., a distinguished board-certified psychiatrist and is considered by many of his colleagues to be the leading psychophysiology researcher in child sexual abuse in the United States. Dr. Abel is a Clinical Professor of Psychiatry, who was for many years a professor and researcher at Columbia University School of Medicine, and currently teaches at both Morehouse School of Medicine and at Emory University School of Medicine.



Abel has directed six National Institute of Mental Health (NIMH) research projects and has published over 130 medical articles in scientific journals. Through these federal research projects he has uncovered new information to help prevent child sexual abuse. Dr. Abel was honored with the Society for Sex Therapy and Research Masters and Johnson Award, The Association for the Treatment of Sexual Abuser's Significant Achievement Award, and The National Adolescent Perpetrator Network's Award for Outstanding Research.

Robin Jenkins Ph.D., Chief Operating Officer (COO) of the North Carolina Department of Juvenile Justice and Delinquency Prevention. For the past 10 years he has served as the Executive Director of Cumberland County CommuniCare Inc., a community based nonprofit that provides and supports prevention / early intervention for at-risk children and their families through community-based collaboration. Jenkins graduated with a Doctorate in Psychology and a concentration in Human Resource Development and Community Psychology from North Carolina State University. He is a member of the American Psychological Association, the American Evaluation Association; the Coalition for Juvenile Justice; and the Society for Community Research.



R. Leslie Nichols, AIA, CPP is the Vice President Club Safety & Design at the Boys & Girls Clubs of America (BGCA). BGCA and its affiliate organizations serve 4 million school-age children, after school at 4,000 facilities located in 50 states, Native American reservations and U.S. military bases here and abroad. Mr. Nichols promotes best practices in child safety on such diverse subjects as: staff screening, child abuse, bullying, workplace violence, technology risks, transportation safety, aquatic safety, sports injuries, building security, health hazards and other topics. Mr. Nichols has been on staff at BGCA since 1994. He is a Certified Protection Professional through the American Society for Industrial Security.



Stacy Pendarvis, MSW, MA is program manager for The Monique Burr Foundation for Children, Inc. Pendarvis has more than 15 years experience working for a variety of agencies in child and family services and child abuse prevention. She is essential in implementing the Foundation's bullying and child abuse program, Speak Up Be Safe™ to all elementary school children in the state of Florida by 2015. Pendarvis is also a Social Work Instructor for the University of North Florida.



Robin McGinnis, M.S.W., is the founder and CEO of Alternative Behavior Treatment Centers (ABTC) and has been working in the mental health field for over 35 years in both the private and public sectors. Alternative Behavior Treatment Centers (ABTC) provides evidence-based treatment for sexually abusive juveniles across the continuum of care. Ms. McGinnis has assisted Dr. Abel with a research protocol currently being funded by First Nonprofit Insurance Company and together they have developed the training course – Better Boundaries.



Nora Harlow is CEO of Abel Screening, Inc., and cofounder, along with Dr. Abel of the Child Molestation Research & Prevention Institute, a national, science-based, nonprofit organization dedicated to the primary prevention of child sexual abuse. She is the author of a book on child care, *Sharing the Children* (Harper & Row), and co-author, with Gene G. Abel, M.D., of a book on the primary prevention of child sexual abuse called *The Stop Child Molestation Book: What Ordinary People Can Do In Their Everyday Lives to Save Three Million Children*.



The Rev. Alicia Schuster Weltner, Canon for Congregational Development & Ministry, directs the programs for exploring ordained vocations to the priesthood and diaconate in the Diocese of Atlanta, in cooperation with the bishop and the Commission on Ministry.



Chuck Hagele, MBA, is the Executive Director of Project PATCH, a non-profit ministry aimed at restoring troubled youth and building stronger families. Since 1987, has worked at youth camps, pastored, and mentored youth. He spent the last nine of those years serving at Project PATCH in various positions including youth ranch administrator, chief operations officer, and his current role as executive director.
