In 2011, over 100,000 OSHA violations were reported, costing companies over \$180 million in compliance-related fines. Averaged out, OSHA fines cost companies about \$1,850 per incident.

1 'DUTY TO HAVE FALL PROTECTION' VIOLATIONS AVERAGE FINE: \$3,234 / CITATION

In 2011, failure to have fall protection equipment (OSHA 1926.501) was was cited more frequently than any other OSHA violation. In 2011 alone, this amounted to over \$23 million in fines.

2 'CONTROL OF HAZARDOUS ENERGY' VIOLATIONS AVERAGE FINE: \$2,276 /CITATION
