Due to the high number of ride requests on St. Patrick's Day, rides cannot be guaranteed for everyone who calls; however, every attempt will be made to accommodate all requests. Drivers have the right to use their discretion when accepting fares.

Safe and Sober Free Ride Home Program

The professionals at McDivitt Law Firm work with clients who have lost loved ones in alcohol-related crashes.
