# Dental Insurance and Your Tax Return

**Do you qualify for a deduction?** The IRS allows taxpayers to take a dental deduction only when the amount of all reported dental + medical expenses exceeds 7.5 percent of adjusted gross income (AGI x .075; see chart below).



### **HSA**

#### Health Savings Accounts (HSAs)

- A tax-exempt trust or custodial account available to U.S. taxpayers
- No permission or authorization from the IRS is needed to set up an HSA
- May be used to pay for qualified dental expenses at any time without liability or penalty
- Contributions made by an employer may be excluded from gross income
- Funds remain in the account from year to year until used
- Interest or other earnings on the assets are tax free

# Flexible Spending Arrangements (FSAs)

- Allows employees to be reimbursed for medical expenses
- There are no reporting requirements
