Form I-9 Entry Validation- Real time validation of data entered into the fields on the electronic Form.	i9AdvantEdge SM automatically checks your Form I-9s for errors as they are being completed to eliminate any human error. Thus reducing fines and penalties due to incomplete or incorrect forms.
Duplication Alert- Users are advised when entering a form for an employee who already has one on file.	This can also be helpful in alerting employers of possible Social Security fraud.
