The four semi-finalist recipes and photos will be posted on the Hinode Rice Facebook page from about Friday, September 14, 2012 to Monday, September 24, 2012 12:00 noon. The recipe with the most "likes" and "favorites" at 12:00noon on Monday, September 24, 2012 will be the potential winner and contacted to confirm ability to complete the terms of the Contest Official Rules. In the event the potential winner cannot confirm their ability to complete the term of the Contest Official Rules, the semi-finalist with the second most "likes" and "favorites" will be deemed the potential winner and so forth until a winner is confirmed and announced.

Winner Announcement: Contest winners will be announced on or about September 26, 2012.
