POLICY INITIATIVES

Now in its ninth year of problem solving for online and distance educational institutions, the Presidents' Forum brings together higher education leaders who have the common attribute of facing the growing challenge to access and productivity. Through this collaborative, the Presidents' Forum has already advanced in three groundbreaking projects:

- **Access to Learning, 2006,** which introduces a wide audience to the methods, advantages, and quality of online learning;
- **Transparency By Design 2008,** which is creating a common, timely, and shareable data reporting process for institutional performance; and currently,
- State Approval and Regional Accreditation for Online Postsecondary Institutions: A National Strategy, a policy initiative to advance new strategies and structures to rationalize the state oversight process, advancing associated regulatory and policy changes while protecting the interests of the public and reducing unnecessary barriers to student access.

With support from Lumina Foundation for Education, the Presidents' Forum is advancing an initiative (Multi-State Reciprocity in Postsecondary Approval and Regulation) to create a common framework for the substance and processes of state approval of institutions, and, with the assistance of the Council for State Governments (CSG), to create and educate policy makers about the benefits of a State Authorization Reciprocity Agreement (SARA) that could support increased reciprocity and efficiencies among the states.

PURPOSE

This meeting will center on issues affecting higher education cost containment for students and the institutions that serve them, and the cost saving contributions offered by online learning and tools for the assessment of prior learning. The program will include the presentation of the Lumina Foundation for Education supported State Authorization Reciprocity Agreement (SARA) Project that is aimed at facilitating access and reducing the cost and time to degree attainment.

SPEAKERS



Jamie P. Merisotis President and CEO Lumina Foundation for Education

Jamie P. Merisotis is President and Chief Executive Officer of Lumina Foundation, the nation's largest private foundation committed solely to enrolling and graduating more students from college. Under his leadership, Lumina employs a strategic, outcomes-based approach in pursuing its mission of expanding college access and success, particularly among low-income, minority and other historically underrepresented populations. Lumina's goal is to increase the percentage of Americans who hold high-quality degrees and credentials to 60 percent by 2025.

Before joining Lumina in January 2008, Merisotis founded and served for 15 years as president of the Washington, D.C.-based Institute for Higher Education Policy, one of the world's premier education research and policy centers. He previously served as executive director of the National Commission on Responsibilities for Financing Postsecondary Education, a bipartisan commission appointed by the president and congressional leaders. Merisotis also helped create the Corporation for National and Community Service (AmeriCorps), and serves on numerous national and international boards of directors, including Bates College, Anatolia College in Greece, the Central Indiana Corporate Partnership, and The Children's Museum of Indianapolis.



Josh Jarrett Deputy Director, Postsecondary Success Bill & Melinda Gates Foundation

Josh Jarrett is a Deputy Director of Postsecondary Success in the U.S. Program of the Bill & Melinda Gates Foundation. He leads the Next Generation Models portfolio within Postsecondary Success. This portfolio supports learning innovations and technologies with the potential to dramatically increase low-income student success and improve affordability. Investments areas include interactive courseware and tools, diagnostic assessments, learner relationship management systems, and breakthrough delivery models. Jarrett has been with the foundation for five years.

Prior to the foundation, Jarrett served as an Engagement Manager in McKinsey & Company's Social Sector Practice, leading nonprofit organizations on issues of strategy, operations and organization. In particular, his work focused on charter school expansion, adolescent health services, and the effectiveness of foundation grantmaking. Prior to McKinsey & Company, Jarrett served as an entrepreneur, helping to launch a customer service software company, and as business planning consultant in the National Park Service.

Jarrett is a graduate of Dartmouth College and he holds a graduate degree in business from the Harvard Business School.
