The Necessities

Why do nurses need seminars on the legal aspects of documentation?

Nursing training is vocational and includes skills, knowledge, and a system of thought that is based on the values, characteristics, and behaviors believed to be best in human beings.

Nurses carry out many roles and functions within a team of healthcare providers including providing patient care, decision making, protecting patients' rights, and providing information. With the evolution of technology, nurses are confronted with issues of malpractice in their practice as the interventions become more invasive.

Medical procedures include the application of medical and nursing science while following accepted rules and processes to effect the diagnosis and treatment of an individual's physical or psychological illnesses or deficiencies. They may also include the relief of symptoms and pain, using a full scope of medical interventions. In the process of, and following medical interventions, the expected results may not always be achieved, and a person who is receiving treatment may suffer harm as a result.

In this situation, the legality of the medical procedures or nursing interventions and the issues of the resultant responsibility of the person or individuals who caused the harm may be questioned, which may lead to an investigation of medical malpractice.

Malpractice can be defined as lack of knowledge or experience, or negligence, in the performance of duties that result in patient injury.

Medical malpractice occurs when a nurse or physician causes harm and/or loss. For example, by not providing adequate service and care in suitable conditions, by not matching the performance expected from a nurse under the same or similar conditions, or by departing from the requirements of accepted practice, leading to substandard care or a breach in the standard of care. There has been an increase in the number of malpractice cases in part, due to an increased awareness of patients' and consumers' rights. Nurses have to bear heavy responsibilities.

Failure to fulfill these responsibilities may result in allegations of negligence that can lead to malpractice lawsuits. Allegations of negligence can arise against a nurse from almost any action or failure to act that results in patient injury (most often, an unintentional failure to adhere to a standard of clinical practice) and may lead to a malpractice lawsuit.

Criminal charges for nursing errors are becoming more prevalent than ever before. The differences between allegations in the civil system "...that adverse events during the course of care contributes to the deaths of 180,000 patients every year..."

and the charges brought in the criminal systems must be understood.
