The CFO of the Year awards program celebrates New Jersey's financial executives at all levels who contribute to the success of New Jersey's economic growth and stability. Finalists were selected in seven categories: Public Company, Private Company with Revenues over \$50MM, Private Company with Revenues up to \$50MM, Nonprofit CFO – Small (50 or fewer employees), Nonprofit CFO – Large (50 or more employees), Best Turnaround Specialist, and Best Growth Manager.

Cheryl obtained her Bachelor of Science degree in Accounting from the Leonard N. Stern School of Business at New York University, and has received a Certification in Process Improvement from Rutgers, The State University of New Jersey, and a Certificate in Treasury Management from Fairleigh Dickinson University.

At Easter Seals New Jersey, among her many financial achievements, most notable is Cheryl's leadership role in developing and improving business models which increased funding for services by \$22 million, enabling the organization to increase the number of consumers served by nearly 20%.

Cheryl also currently serves as the Co-Chair for the CFO Committee of the New Jersey Association of Mental Health and Addictions Agencies (NJAMHAA) from which she was also recently presented with the Outstanding Leadership in Advocacy on Fiscal Issues award, in recognition of her role in the initiative on NJAMHAA's rate-setting workgroup, which gathers data to determine what fee-for-service reimbursement rates should be - critical information that NJAMHAA will use as a basis for its proactive advocacy to the state on these rates.

"The dedicated work and successes achieved by Cheryl have fundamentally allowed life-changing work to flourish year after year for thousands of individuals in need," says Brian Fitzgerald, President and CEO of Easter Seals New Jersey. "She has also served as a consultant and advisor to other Easter Seals affiliates across the nation by sharing her expertise in cash management, financial systems and financial leadership. Moreover, several state associations and provider organizations seek her advice and counsel."
