INSTRUCTIONS TO SUBMIT YOUR DRAFT PAPER:

To Submit Electronically (preferred):

- -Email your completed draft paper and submission form to Anh Lay at alay@geothermal.org by May 3, 2013.
 - 1) A completed draft paper with all illustrations (including tables, figures, charts, photos, and maps) embedded within the text. The file must be in word or pdf format. Papers must not exceed 7,000 words (fourteen single-spaced pages), including references, charts, maps, graphs, figures, diagrams, tables, and other illustrations. Text should be set up in single-column, full page width format with one-inch margins, single-spaced text, with one blank line between paragraphs. Use 12-point Times New Roman Font for all text. Use bold headings and subheadings within the text.
 - a) Please include a minimum of 5-10 keywords below the title and author(s) on the first page of your paper(s).
 - **b)** References to published literature must be fully cited at the end of the paper. Unreliable sources such as Wikipedia must <u>never</u> be cited.
 - (i) Individual references should include the following in sequence: author's last name, then first name, co-authors (with first name initials followed by last name), date of publication, paper title, journal or publisher, volume number, and page number. Sample: Allis R., J.N. Moore, J. McCulloch, S. Petty, and T. DeRocher, 2000. "Karah-Telaga Bodas, Indonesia: A Partially Vapor Dominated Geothermal System." Geothermal Resources Council *Transactions*, v. 24, p. 217-222.
 - 2) A completed submission form
 - A signed consent form to use and reproduce your paper (all authors and coauthors must sign the document)

- 1) A print copy of your draft paper
 - a) A completed draft paper with all illustrations (including tables, figures, charts, photos, and maps) embedded within the text. The file must be in word or pdf format. Papers must not exceed 7,000 words (fourteen single-spaced pages), including references, charts, maps, graphs, figures, diagrams, tables, and other illustrations. Text should be set up in single-column, full page width format with one-inch margins, single-spaced text, with one blank line between paragraphs. Use 12-point Times New Roman Font for all text.  - i) Please include a minimum of 5-10 keywords below the title and author(s) on the first page of your paper(s).
 - **ii)** References to published literature must be fully cited at the end of the paper. Unreliable sources such as Wikipedia must <u>never</u> be cited.

- (i) Individual references should include the following in sequence: author's last name, then first name, co-authors (with first name initials followed by last name), date of publication, paper title, journal or publisher, volume number, and page number.

- 2) A print copy of your completed submission form
- A signed consent form to use and reproduce your paper (all authors and coauthors must sign the document)
- 4) A CD-ROM containing a copy of your draft paper and submission form.

Draft papers will be reviewed on May 13-14, 2013 and Authors will be notified of their status (accepted/rejected) during the week of May 20-24, 2013. All accepted Authors will be given further instructions upon notification. Please note that the Final Paper instructions will be different from that of the instructions included in this email. If your draft paper is accepted then you will be required to submit a Final Draft of your technical paper regardless if you are presenting a poster and/or an oral presentation. We require a completed technical paper for both poster and oral presentations because <u>all</u> papers are published in the GRC's *Transactions* Volume CD-ROM unless otherwise specified. GRC 2013 Annual Meeting Deadlines

May 3	Deadline for submission of Draft Papers.
May 13-14	Draft Papers will be reviewed by 2013 Annual Meeting Technical Committee
May 20-24	Authors will be notified of their draft paper status (accepted or rejected). All accepted authors will receive further instructions on how to submit and format their final draft.
June 7	Deadline for submission of Final Technical Papers. Authors must submit a final corrected and formatted copy of their paper specified by the <i>Author Instructions</i> . Adherence to this deadline is a necessary condition of final paper acceptance.
July 31	Deadline for authors to confirm that they will attend the Annual Meeting. Without this confirmation, presentations will be removed from the Final Program.
September 20	Deadline for oral presenters to submit their PowerPoint presentations to the GRC via its FTP upload link (instructions and link will be provided to authors prior to the deadline).
