Due to the high number of ride requests on New Year's Eve, rides cannot be guaranteed for everyone who calls; however, every attempt will be made to accommodate all requests. Drivers have the right to use their discretion when accepting fares.

### Safe and Sober Free Ride Home Program

The legal professionals at McDivitt Law Firm work with clients who have lost loved ones in alcohol-related crashes.
