# Ambassador FAQ

## **How do I apply for the Maan Health Ambassador Program?**

To apply, please fill out and submit your application by its appropriate deadline. Applications can be submitted via email to [marketing@maanhealth.com](mailto:marketing@maanhealth.com).

## **When is the best time to apply?**

For each calendar year, Ambassador Applications will be available online from January 1<sup>st</sup> thru April 30<sup>th</sup> and all applications received after April 30<sup>th</sup> will be considered for the *following* calendar year.

## **What does the program consist of?**

Once selected for the Program, Ambassadors will receive one shipment immediately. Marketing Materials may also be provided upon request to educate your clients/patients on Maan Health and our products. Upon review of your report of promotional activities, Maan Health may decide to send a second shipment of samples to the ambassador.

## **Can I still apply if I miss the submission deadline?**

Unfortunately, we must receive all applications by the specified deadlines of April 30<sup>th</sup> to be considered. We encourage you to mark your calendar for the next application deadline.

**Will you notify me whether or not I am selected for the Ambassador Program?** Because we receive an extraordinary amount of applications, we cannot respond to all applicants. If selected, you will be contacted via telephone or email before May 15<sup>th</sup> of each year.

## **If I'm selected for the Ambassador Program this year, do I have to reapply next year?**

Our program runs on a (1) year cycle. You are required and encouraged to reapply and update your information each year.

## **What am I required to do by MAAN HEALTH while I'm an Ambassador?**

As an Ambassador, we are very interested in how you are promoting MAAN HEALTH. Once per year, we ask for a summary of your promotion of MAAN HEALTH. This will include examples of how you distributed your product, any comments you or your clients have, any suggestions you have on MAAN HEALTH and the Ambassador Program, and any testimonials and/or photos you would like to submit.
