

## **Operation Safe Driver Results—2011-2012**

## Additional details:

- 28,510 CMV Roadside Inspections: 6.1% resulted in the driver being declared out-of-service (OOS); 26.2% of the Level I inspections resulted in the vehicle(s) being declared OOS, a slight increase from the 4.7% for drivers and the 24.6% recorded in 2011. For Drivers: an average of 0.5 violations per roadside inspection (0.81 in 2011); an average of .09 OOS violations per roadside inspections versus 0.08 recorded in 2011, an average of 0.5 citations per inspection and 0.07 in 2011.
- For Vehicles: an average of 1.18 violations per roadside inspection and 0.09 citations per roadside inspection.
- 16,781 CMV Driver Traffic Enforcement Contacts: 6,501 warnings (7,063 in 2011) were issued this year —an average of 0.39 per contact; 7,443 citations were issued—an average of 0.31 per contact compared to the 20,801 CMV contacts and 8,121 citations issued with an average of 0.35 per contact issued in 2011.
- 5,982 Non-CMV Driver Traffic Enforcement: 3,942 warnings were issued—an average of 0.66 per contact; 7,443 citations were issued—0.31 per contact; In 2011, there were 8,770 contacts, 7,126 warnings—0.52 average per contact and 7,256 citations issued—0.69 average per contact.
- 25,026 CMV Driver License checks (32,998 in 2011) and 5,413 Non-CMV Driver License checks (8,192 in 2011).
- FMCSA conducted 452 targeted Compliance Reviews on truck and motorcoach operations that
  employ the "worst of the worst" commercial drivers. Of the 94 reviews resulting in a safety
  rating, 61 carriers (or 64.9%) received a Conditional Safety Rating—compared to the national
  average of carriers rated Conditional in 2012 which was 37.3%. A total of 13 carriers (or 4.8%)
  received an Unsatisfactory Safety Rating. The national average of carriers rated unsatisfactory
  in 2012 was 3.7%.
