Do we have to let OSHA in? Should I call my attorney? Can I ask OSHA to wait? Who should be present? Ask him directly! These questions and more are addressed in this session which will overview how a typical OSHA Inspection is conducted, including employer and employee rights and responsibilities. This provides attendees with a great "where do I start" point for their own safety assessments, as well as providing safety reminders for seasoned safety supervisors.

11:15am- 12pm How Do I Comply with the New GHS?

Session overviews the key changes of the Hazard Communication Standard and what an employer should do to prepare for these changes.
