## Santa Monica Accountant Prepares for the Indian Film Festival of Los Angeles

SANTA MONICA, Calif. – April 3, 2013 – "When you are passionate about supporting a cause you believe in, you can make things happen." says Shreedhar (Shree) Kothari of Gumbiner Savett Inc., a Santa Monica, California based accounting firm.
